If I could, my motion would be to send this to the transportation committee to make this an official part of their transportation master plan.

 - i. Pitre: Previously, we discussed Master Plan collaboration with Nathan from WSP. He said that he would send us bits and pieces to review and we would send them back with our thoughts. We have not received any main parts yet, but we did get an outline for review.
 - ii. Suggestions/observations:
 - 1. We can add in information for the economic corridor and legacy issues, as you all had mentioned.
 - 2. The new outline added a public outreach topic.
 - 3. The old outline has implementation strategies within each topic, as well as in its own category.
