WHEREAS, by the official plat of MAP SHOWING REVOCATION OF A CERTAIN 40' SERVITUDE OF ACCESS & A CERTAIN 60' SERVITUDE OF ACCESS LOCATED IN SECTION 41, T8S-R3E, G.L.D., LIVINGSTON PARISH, LOUISIANA FOR ADRIAN JENKINS:
