NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on September 14, 2017, and laid over for publication of notice:

LIVINGSTON PARISH ORDINANCE NO. 17-34

AN ORDINANCE TO AMEND AND REENACT SECTION 10-9, "STOP SIGNS," OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON, TO ADD THE INTERSECTIONS OF R. DAWES AND DIALTHA AND R. DAWES AND PAGE AND R. DAWES AND STANTON HALL AND R. DAWES AND ROSALIE AND WYETH AND PAGE AND WYETH AND LUCAS AND WYETH AND STANTON HALL AND WYETH AND OLA AND PAGE AND OLA AND MARY AND STANTON HALL AND MARY AND LUCAS.

The following ordinance, which was previously introduced in written form at a regular meeting of the Parish Council on September 14, 2017 a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage September 28, 2017, on motion of Garry Talbert and seconded by Jeff Ard:

WHEREAS, Chapter 10 of the Code of Ordinances in and for the Parish of Livingston, "Motor Vehicles and Traffic," contains a section, more specifically Section 10-9(a) and (b), designating specific intersections as three-way stops and four-way stops and ordering the installation of stop signs.

WHEREAS, La. R.S. 32:42 authorizes local parish authorities to adopt ordinances to regulate, designate, direct and restrict vehicular traffic on highways other than state maintained highways and with respect to public roads within their territorial limits, but outside corporate limits of any municipality therein.

THEREFORE, BE IT ORDAINED by the Livingston Parish Council that Section 10-9(a) and (b) of the Code of Ordinances of the Parish of Livingston, State of Louisiana, is hereby amended as follows:

SECTION 1. Add the following intersections to the list of intersections contained in Section 10-9 (a)

Three-way stop(s):

R. Dawes and Dialtha
R. Dawes and Page
R. Dawes and Stanton Hall
R. Dawes and Rosalie
Wyeth and Page
Wyeth and Lucas
Wyeth and Stanton Hall
Wyeth and Ola
Page and Ola
Mary and Stanton Hall

SECTION 2. Add the following intersection to the list of intersections contained in Section 10-9 (b)

Four-way stop:

Mary and Lucas

SECTION 3. The effective date of this ordinance shall be as prescribed by law.

SECTION 4. The above and foregoing addition to the Code of the Parish of Livingston, having been properly introduced and published by title, was thereupon submitted to a vote; the vote thereon was as follows:
