NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on February 22, 2018, and laid over for publication of notice:

**L.P. ORDINANCE 18-03**

AN ORDINANCE TO AMEND CHAPTER 13, "PLANNING AND DEVELOPMENT," SECTION 13-54.1, "STREET STANDARDS", PART (A), TO INCLUDE THE CRITERIA AND REGULATIONS OF THE LATEST EDITION OF THE LOUISIANA DOTD STANDARD SPECIFICATIONS FOR ROADS AND BRIDGES, OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on February 22, 2018, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice was brought up for final passage March 8, 2018, on Motion of Shane Mack and seconded by Tracy Girlinghouse:

**L.P. ORDINANCE 18-03**

AN ORDINANCE TO AMEND CHAPTER 13, "PLANNING AND DEVELOPMENT," SECTION 13-54.1, "STREET STANDARDS", PART (A), TO INCLUDE THE CRITERIA AND REGULATIONS OF THE LATEST EDITION OF THE LOUISIANA DOTD STANDARD SPECIFICATIONS FOR ROADS AND BRIDGES, OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P.O. 01-16, reenacting Chapter 13 of the Code of Ordinances of Livingston Parish, Subdivision Regulations, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 13 of the Code of Ordinances and now desires to amend Section 13-54.1, "Street Standards", Part (a) to include the criteria and regulations set forth by the Louisiana DOTD Standard Specifications for Roads and Bridges, 2016 Edition (or latest);

THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: The Code of Ordinances of Livingston Parish, Section 13-54.1, "Street Standards," Part (a) is hereby amended to read as follows:

**SEC. 13-54.1. STREET STANDARDS**

- A. All new roads/streets (private or public) shall be paved and constructed in accordance with these regulations and to Louisiana DOTD Standard Specifications for Roads and Bridges, 2016 Edition (or latest). These LA DOTD Standards Specifications will specifically apply for any roadway base work, asphalt work, concrete work (including curbs) and subsurface drainage (with exception of side drain inlets; Parish inlets shall still be required but constructed using DOTD specifications). The O/D/S that constructs a private road shall be required to obtain a signed affidavit from all buyers located on the private road acknowledging it is a private road and not maintained by the parish. A copy of the signed affidavit must be sent to the parish council office. A large note shall be placed on the final plat stating the following: **BUYER BEWARE --- THE STREETS, ROADS, SERVITUDES AND RIGHTS OF WAY IN THIS SUBDIVISION WILL NOT BE MAINTAINED BY THE LIVINGSTON PARISH COUNCIL OR ANY OTHER PUBLIC BODY.**

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
