## L.P. ORDINANCE 18-18

AN ORDINANCE TO AMEND CHAPTER 5.5, "ENVIRONMENT," SECTION 5.5-31, "DEFINITIONS" BY DEFINING A "SECURE YARD", AND BY ADDING SECTION 5.5-38, "REMOVAL OF ABANDONED AND INOPERATIVE VEHICLES" OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, on July 24, 1997, the Livingston Parish Council adopted L.P.O. 97-12, prohibiting the accumulation and storage of abandoned and/or inoperative motor vehicles on all private property and providing penalties for failure to adhere to any part of,

WHEREAS, the Livingston Parish Council now desires to add the definition of "Secure yard" to Section 5.5-31, "Definitions", and add Section 5.5-38, "Removal of Abandoned and/or Inoperative Vehicles",

THEREFORE, BE IT ORDAINED the governing authority of the Parish of Livingston, State of Louisiana: The Code of Ordinances of Livingston Parish, Section 5.5-31, "Definitions," is hereby amended to read as follows:

Secure yard – A secure yard is a designated piece of property that is enclosed by a fence, or barrier, at least six (6) foot in height.

NOW, BE IT FURTHER ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the Code of Ordinances of Livingston Parish, Section 5.5-38, "Removal of Abandoned and/or Inoperative Vehicles," is hereby added to read as follows:

## Section 5.5-38 Removal of Abandoned and/or Inoperative Vehicles

All abandoned and/or inoperative vehicles that are removed under authority of this ordinance will be moved by a state licensed wrecker service. The wrecker will be dispatched from a rotating wrecker list established by the Director of Public Works.

NOW, THEREFORE, BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
