**L.P. ORDINANCE 19-07**

AN ORDINANCE AMENDING AND CLARIFYING THE BOUNDARIES OF MOSQUITO ABATEMENT DISTRICT TWO AND THREE OF THE PARISH OF LIVINGSTON, STATE OF LOUISIANA AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

The following Ordinance which was previously introduced in written form at a regular meeting of the Parish Council of the Parish of Livingston, State of Louisiana on February 28, 2019, a Notice of Public Hearing having been published in the official journal and which public hearing was held in accordance with said public notice, was offered by Garry “Frog” Talbert and seconded by Maurice “Scooter” Keen:

**L.P. ORDINANCE NO. 19-07**

**AN ORDINANCE AMENDING AND CLARIFYING THE BOUNDARIES OF MOSQUITO ABATEMENT DISTRICT TWO AND THREE OF THE PARISH OF LIVINGSTON, STATE OF LOUISIANA AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.**

WHEREAS, pursuant to the authority set forth in Sub-Part A, Part I, Chapter 9 of Title 33 of the Louisiana Revised Statutes of 1950, as amended and the Livingston Parish Home Rule Charter, the Parish Council of the Parish of Livingston, State of Louisiana, acting as governing authority of the Parish of Livingston, State of Louisiana (the “*Governing Authority*”) created Mosquito Abatement District Two and Three of the Parish of Livingston, State of Louisiana (the “*District*”) by L.P. Ordinance No. 18-15 adopted on April 26, 2018 (the “*Boundary Ordinance*”); and

WHEREAS, the Governing Authority now desires to amend and clarify the boundaries of the District to ensure that only unincorporated areas are included within the District; and

WHEREAS, the Governing Authority may alter the boundaries of the District, upon their own initiative under Sub-Part A, Part I, Chapter 9 of Title 33 of the Louisiana Revised Statutes of 1950, as amended; and

WHEREAS, the aforementioned boundary change will not cause an impairment of the obligations of any contract of the District; and

NOW, THEREFORE, BE IT ORDAINED by the Governing Authority, that:

SECTION 1. Section 1 of L.P. Ordinance No. 18-15 shall be amended to read as follows:

“That by virtue of the authority conferred by Chapter 23 of Title 33 of the Louisiana Revised Statutes of 1950, as amended (the “Act”), and other constitutional and statutory authority, a mosquito abatement district is hereby created within the Parish of Livingston, State of Louisiana, which mosquito abatement district shall comprise and embrace all of the territory within the following described boundaries, to-wit:

District 2: Beginning at the intersection of the centerline of Spillers Creek and the northern parish boundary, proceed easterly along the northern parish boundary to the centerline of an unnamed road; then southeasterly and southwesterly to the centerline of Cassie Drive; then southerly to the centerline of LA Hwy. 63; then westerly to the centerline of LA Hwy. 1023; then southerly and southwesterly to the centerline of an unnamed road; then easterly to the centerline of another unnamed road; then southerly and northwesterly to the centerline of an unnamed waterway (between LA Hwy. 1023 and Walker Road North); then southerly to the centerline of LA Hwy. 1019 (Springfield Road); then westerly to the centerline of West Colyell Creek; then southerly to the centerline of LA Hwy. 1024 (Cane Market Road); then westerly to the centerline of LA Hwy. 16; then southerly to the centerline of LA Hwy. 1024 (Hunstock Road); then westerly to the centerline of LA Hwy. 1019; then northerly to the centerline of an unnamed waterway south of Foxboro Drive; then westerly to the eastern parish boundary (the centerline of the Amite River); then northerly to the northern parish boundary; then easterly to the centerline of Spillers Creek and the point of beginning.

District 3: Beginning at the intersection of the western parish boundary (the centerline of the Amite River) and an unnamed waterway south of Foxboro Drive, proceed easterly along the centerline of the unnamed waterway to the centerline of LA Hwy. 1019; then southerly to the centerline of LA Hwy. 1024 (Hunstock Road);

then easterly to the centerline of LA Hwy 16; then northerly to the centerline of LA Hwy 1024 (Cane Market Road; then easterly to the centerline of West Colyell Creek; then southerly to the centerline of LA Hwy. 1026 (Lockhart Road); then proceed southeasterly to the centerline of the Canadian National Railroad; then westerly to the centerline of Gray’s Creek; then northerly easterly and northerly to the centerline of the LA Hwy. 1026 (Lockhart Road); then westerly to the centerline of LA Hwy. 1030 (Cockerham Road); then proceed southwesterly to the corporate boundary line of the City of Denham Springs; thence westerly along the corporate boundary line of the City of Denham Springs to the centerline of LA Hwy 16 (Range Avenue); then northerly to the centerline of LA Hwy. 64 (Magnolia Beach Road); then northwesterly and westerly to the western parish boundary (the centerline of the Amite River); then northerly to the centerline of an unnamed waterway south of Foxboro Drive and the point of beginning.

Said description of the boundaries of Livingston Parish Council Districts two and three being taken from the Proposed Redistricting Plan for the Parish Council from June 2011, Booklet 1 prepared by Garnet Innovations, LLC.”

SECTION 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. If any provision of this Ordinance is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance, which can be given effect without the invalid provision, or application, and to this end the provision of this Ordinance are hereby declared severable.

SECTION 4. The Chairman and Council Clerk of the Governing Authority, along with the Parish President, are further authorized and directed to do any and all things necessary and incidental to carry out the provisions of this Ordinance.
