

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Livingston Parish Council on July 11, 2019, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage August 8, 2019, on Motion of Garry “Frog” Talbert and seconded by Maurice “Scooter” Keen:

L.P. ORDINANCE NO. 19-23

AN ORDINANCE TO RESCIND L.P. ORDINANCE NO. 18-15, ADOPTED ON APRIL 26, 2018, PROVIDING FOR THE CREATION OF MOSQUITO ABATEMENT DISTRICT TWO AND THREE AND ESTABLISHING A BOARD IN THE PARISH OF LIVINGSTON, STATE OF LOUISIANA, AND L.P. ORDINANCE NO. 19-07 ADOPTED ON MARCH 14, 2019, AMENDING AND CLARIFYING THE BOUNDARIES OF MOSQUITO ABATEMENT DISTRICT TWO AND THREE, COMPRISING ALL THAT TERRITORY IN THE PARISH AS SET OUT HEREIN AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Livingston Parish Council, adopted L.P. Ordinance No. 18-15, on April 26, 2018, whereby creating the Mosquito Abatement District Two and Three and establishing a Mosquito Abatement board in the Parish of Livingston comprising all that territory in the Parish as set out therein as provided by Louisiana Revised Statute 33:7721; and

WHEREAS, the Livingston Parish Council, adopted L.P. Ordinance No. 19-07, on March 15, 2019, whereby creating the Mosquito Abatement District Two and Three and establishing a Mosquito Abatement board in the Parish of Livingston comprising all that territory in the Parish as set out therein as provided by Louisiana Revised Statute 33:7721; and

WHEREAS, the Livingston Parish Council now wishes to rescind L.P. Ordinance No. 18-15 and L.P. Ordinance No. 19-07 and abolish the Mosquito Abatement District and its board, based on the response and comment from its constituents and the outcome of the May 4, 2019, whereby the Parish electorate voted to not fund the mosquito abatement program in the boundaries of Mosquito Abatement District Two and Three in the Parish of Livingston; and

WHEREAS, in order to abolish and terminate the duties and responsibilities of the District as set forth in L.P. Ordinance No. 18-15 and L.P. 19-07, it is now desirable and necessary to act by ordinance of the Livingston Parish Council.

NOW, THEREFORE, BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana:

The Mosquito Abatement District Two and Three created by authority of Chapter 23 of Title 33 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority and

introduced and adopted by the Livingston Parish Council as L.P. Ordinance No. 18-15 adopted April 26, 2018 and L.P. Ordinance No. 19-07 adopted on March 15, 2019, is hereby formally dissolved.

The duly appointed governing authority of the Mosquito Abatement District Two and Three of the Parish of Livingston, State of Louisiana, is hereby resolved of the responsibilities and duties assigned to it under the provisions of State and local law.

The adoption of this ordinance shall serve as proper authority for Livingston Parish to assume responsibility for any and all moveable and/or immoveable property formally held by the Mosquito Abatement District Two and Three to which it has legal right and obligation.

BE IT FURTHER ORDAINED that any and all resolutions and ordinances, or parts thereof, conflicting herewith are hereby repealed.

BE IT FURTHER ORDAINED that upon adoption this ordinance shall become effective July 25, 2019 subsequent to its adoption and the signature of approval of the Livingston Parish President.
