The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on January 23, 2020, a summary thereof having been published in the Official Journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage February 6, 2020, on Motion of Garry "Frog" Talbert and seconded by John Wascom:

**L.P. ORDINANCE 20-03**

AN ORDINANCE TO AMEND SECTION 2-2, "LIVINGSTON PARISH COUNCIL – REGULAR AND SPECIAL MEETINGS", OF THE CODE OF ORDINANCES OF LIVINGSTON PARISH BY AMENDING THE TIME AND HOUR OF REGULAR MEETINGS OF THE LIVINGSTON PARISH COUNCIL FROM SIX-THIRTY (6:30) P.M. TO SIX O’CLOCK (6:00) P.M.

WHEREAS, prior to October 1, 1994, Livingston Parish was under the Police Jury form of government; and

WHEREAS, the electorate voted favorable to adopt a Home Rule Charter form of government on October 1, 1994, and

WHEREAS, the Livingston Parish Council has determined that references to the Police Jury form of government contained in Chapter 2 of the Code of Ordinances should be changed to accurately reflect the President-Council government; and

WHEREAS, the Livingston Parish Council has determined that the time and hour of the regular meetings of the Council should be modified to meet and reflect an established procedure set by the governing authority for the proper management of its affairs.

THEREFORE, BE IT ORDAINED by the Council of the Parish of Livingston, State of Louisiana, that Section 2-2 of the Code of Ordinances of Livingston Parish is hereby repealed in their entirety and reinstated to read as follows:

**Sec. 2-2. Livingston Parish Council - Regular and special meetings.**

The time and dates of regular meetings of the Livingston Parish Council are set for the second and fourth Thursday of each month at the hour of six o’clock (6:00) p.m.

Special meetings may be held on the call of the presiding officer of the Council or a majority of the authorized membership of the Council with such notice as may be required by state law.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
