NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on May 28, 2020, and laid over for publication of notice:

**L.P. ORDINANCE NO. 20-06**

AN ORDINANCE TO AMEND ARTICLE III, "PARKING", DIVISION 2, "REGULATIONS AND EXCEPTIONS" OF CHAPTER 46, "MOTOR VEHICLES AND TRAFFIC", OF THE CODE OF ORDINANCES OF LIVINGSTON PARISH, BY ADDING SECTION 46-94, "PENALTIES FOR VIOLATIONS", BY ESTABLISHING A PENALTY FEE OF UP TO TWO HUNDRED FIFTY DOLLARS (\$250.00) PER VIOLATION OCCURANCE.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on May 28, 2020, a summary thereof having been published in the Official Journal together with a notice of Public Hearing which was held in accordance with said Public Notice was brought up for final passage June 11, 2020, on Motion of Jeff Ard and seconded by R.C. "Bubba" Harris:

**L.P. ORDINANCE NO. 20-06**

AN ORDINANCE TO AMEND ARTICLE III, "PARKING", DIVISION 2, "REGULATIONS AND EXCEPTIONS" OF CHAPTER 46, "MOTOR VEHICLES AND TRAFFIC", OF THE CODE OF ORDINANCES OF LIVINGSTON PARISH, BY ADDING SECTION 46-94, "PENALTIES FOR VIOLATIONS", BY ESTABLISHING A PENALTY FEE OF UP TO TWO HUNDRED FIFTY DOLLARS (\$250.00) PER VIOLATION OCCURANCE.

WHEREAS, the Livingston Parish Council adopted L.P. Ordinance Number 99-21, given by the authority of Louisiana Revised Statute 32:143, at a meeting held on January 13, 2000, in which meeting a quorum was present; and

WHEREAS, the Livingston Parish Council now desires to add a provision establishing a specific penalty fee in the amount up to two hundred fifty dollars (\$250.00) for each parking violation occurrence in the Parish of Livingston;

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: The Code of Ordinances of Livingston Parish, Article III, "Parking" of Section 46-94, "Penalties for Violations", is hereby added to Chapter 46, "Motor Vehicles and Traffic", to read as follows:

**Section 46-94 Penalties for Violations**

Each violation of this chapter or any regulation, order, or ruling promulgated hereunder, shall constitute a misdemeanor and shall be punishable by a fine of up to two hundred fifty dollars (\$250.00).

In addition, the violator shall pay all costs and expenses involved in the case. Nothing in this Section shall prevent the Parish Council from taking other lawful action as is necessary to prevent or remedy any violation.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
