NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on June 25, 2020, and laid over for publication of notice:

AN ORDINANCE TO RESCIND AND REENACT CHAPTER 70, "UTILITIES," ARTICLE V, "SEWAGE DISPOSAL SYSTEMS", SECTION 70-266, "INSPECTION," OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON TO AMEND THE GUIDELINES FOR REQUIRED SEWER PERMITS.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on June 25, 2020, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice was brought up for final passage July 9, 2020, on Motion of Tracy Girlinghouse and seconded by Jeff Ard:

AN ORDINANCE TO RESCIND AND REENACT CHAPTER 70, "UTILITIES," ARTICLE V, "SEWAGE DISPOSAL SYSTEMS", SECTION 70-266, "INSPECTION," OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON TO AMEND THE GUIDELINES FOR REQUIRED SEWER PERMITS.

WHEREAS, the Livingston Parish Council adopted L.P.O. 98-07, reenacting Chapter 70 of the Code of Ordinances of Livingston Parish, Utilities, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 70 of the Code of Ordinances and now desires to further amend Section 70-266, "Inspection" requiring the Public Health Officer to inspect existing sewer systems every two (2) years unless the approved sewer system has been serviced or recertified;

WHEREAS, the Livingston Parish Council now wishes to amend Chapter 70, "Utilities", Article V, "Sewage Disposal Systems", Section 70-266, "Inspection", establishing new guidelines for required sewer permits;

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: The Code of Ordinances of Livingston Parish, Section 70-266, is hereby deleted in its entirety and reenacted to read as follows:

ARTICLE V. – SEWAGE DISPOSAL SYSTEMS

Section 70-266.- Inspection

For new sewer systems before final approval is issued, the state health officer or his authorized agent shall receive certification of the installed sewage disposal system.

For existing sewer systems, if approved sewage system has not been inspected within two (2) years, before final approval is issued, the state health officer or his authorized agent shall inspect the installed sewage disposal system. If approved sewage system has been serviced or recertified within two (2) years inspection shall not be done by the state health officer or his authorized agent.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
