NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on January 28, 2021, and laid over for publication of notice:

AN ORDINANCE TO AMEND CHAPTER 22, "ENVIRONMENT," SECTION 22-22, "SPECIFIC PROHIBITIONS", AND AMEND BY ADDING SECTION (A)(1), ADDING PROVISIONS FOR THE USE OF OUTSIDE SOUND SYSTEMS OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on January 28, 2021, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice was brought up for final passage February 11, 2021, on Motion of Tracy Girlinghouse and seconded by Gerald McMorris:

L.P. ORDINANCE NO. 21-01

AN ORDINANCE TO AMEND CHAPTER 22, "ENVIRONMENT," SECTION 22-22, "SPECIFIC PROHIBITIONS", AND AMEND BY ADDING SECTION (A)(1) AND (B), ADDING PROVISIONS FOR THE USE OF OUTSIDE SOUND SYSTEMS OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P. NO. 19-16 on June 13, 2019, an ordinance adopting and enacting a new code for the Code of Ordinances of Livingston Parish, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to the Code of Ordinances and now desires to amend Chapter 22, "Environment", Section 22-22, "Specific prohibitions", formerly known as Chapter 5.5, Section 5.5-14, and

WHEREAS, the Livingston Parish Council now finds it necessary to amend Section 22-22, "Specific prohibitions", by adding Parts (a)1 and (b), adding provisions and time restrictions on the use of a public address system (PA system) and/or any sound system that is located outside of a business or residence for the purpose of playing any radio or musical, or of any type of music or the projecting of any instrument after the hours of ten o'clock (10:00) p.m. until the seven o'clock (7:00) a.m.

THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: The Code of Ordinances of Livingston Parish, Chapter 22, "Environment", Section 22-22 "Specific prohibitions", is hereby amended to read as follows by adding Parts (a) (1) and (b) :

Section 22-22, Sub-Section (a)(1)(b):

- (a) (1) It shall be unlawful to use a public access system (PA system) and/or any sound system or to have any amplified music or sound that is coming from a speaker or a device that is located outside of a business for the purpose of playing any radio, or musical, or any type of music, or the projection of any type of instrument after the hours of ten o'clock (10:00) p.m. until seven o'clock (7:00) a.m.
- (b) Non-profit organizations, churches and schools shall be exempt from these prohibitions.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
