L.P. ORDINANCE 19-39

AN ORDINANCE TO AMEND CHAPTER 50, "OFFENSES - MISCELLANEOUS", OF THE CODE OF ORDINANCES OF LIVINGSTON PARISH, BY ADDING SECTION 50-15, "SYRINGE SERVICES PROGRAM"

WHEREAS, pursuant to Louisiana Revised Statutes Title 40 § 1024(C) (La. R.S. 40:1024(C)), the Livingston Parish Council wishes to authorize the establishment and implementation of a syringe services program by an organization, including a nonprofit community-based organization or local health department; and

WHEREAS, the proposed addition authorizes an organization to establish and implement a needle exchange program in the Parish of Livingston; and

WHEREAS, the proposed ordinance decriminalizes distribution and/or possession of hypodermic needles and syringes by said organizations and by participants in the program; and

WHEREAS, the organizations participating in said syringe service programs may be considered a "social service center" or "government office"; and

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana, that the Code of Ordinances of Livingston Parish, Chapter 50, "Offenses-Miscellaneous", is hereby amended by adding Section 50-15, "**Syringe Services Program**", to read as follows:

Section 50-15. SYRINGE SERVICES PROGRAM

Definitions:

Syringe access program is any evidence-based program run by a governmental or nongovernmental organization or individual that includes in its mission or function the storage or distribution of hypodermic needles, syringes, or other drug related objects or drug use supplies for a legitimate public health purpose of preventing the spread of bloodborne infectious diseases

Authorization:

An organization, including a nonprofit community-based organization or local health department shall be authorized to provide needle and syringe exchange services to prevent and reduce the transmission of communicable diseases through a syringe services program. Individual participants in such a program shall be offered an identification card by the organization which readily identifies the person as a lawful participant in the program.

- 1. The objectives of such program shall include the following:
 - a. Reduce the spread of HIV, AIDS, viral hepatitis, and other blood-borne diseases in the parish
 - b. Reduce needle stick injuries to law enforcement officers and other emergency personnel.
- 2. Programs established pursuant to this section may offer all of the following:
 - a. Disposal of used needles and hypodermic syringes.
 - b. Needles, hypodermic syringes, and other drug use supplies in quantities sufficient to ensure that needles, hypodermic syringes, and other drug use supplies are not shared or reused.
 - c. Educational materials on the following:
 - i. Overdose prevention.
 - ii. The prevention of HIV, AIDS, and viral hepatitis transmission.
 - iii. Drug abuse prevention.
 - iv. Treatment for mental illness, including treatment referrals.
 - v. Treatment for substance abuse, including referrals for medication assisted treatment.
 - d. Access to naloxone kits that contain naloxone hydrochloride that is approved by the federal Food and Drug Administration for the treatment of a drug overdose.

- 3. Supplies and materials distributed by a program pursuant to this section shall be distributed at no cost to participants.
- 4. Persons acting as employees or volunteers of an organization, including a nonprofit community-based organization or local health department that provides needle and syringe exchange services to prevent and reduce the transmission of communicable diseases, or participants in such a program as defined in this section shall not be guilty of distributing and/or possessing hypodermic needles and syringes.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
