AN ORDINANCE RESCINDING L.P. WHEREAS, the Livingston Parish Council was previously informed that a certain 40' and 50' Servitude of Access was no longer needed for public purposes by virtue of a petition from current owner John Cooper Fore, and as a result thereof, the Council took action to revoke the 40' and 50' servitudes of access located on Tract A being a 32.83 acre tract of land of the remaining portion of the John Cooper Fore property located at 33365 LA Hwy. 1019, Denham Springs, LA located in Sections 61 and 64, T6S-R2E, G.L.D., Livingston Parish, Louisiana as shown on a survey by Alvin Fairburn and Associates, LLC., dated January 16, 2020 and recorded as Plat Book Entry _____ in the office of the Clerk and Recorder for the Parish of Livingston, State of Louisiana, attached hereto and made a part hereof by reference, is located a 40' and 50' Servitude of Access.

WHEREAS, the Council has now been advised that the servitude of access in question is still being used for a public purpose, and therefore the Council now wishes to rescind the previous Revocation.

BE IT THEREFORE ORDERED by the Livingston Parish President and Council that Livingston Parish Ordinance No. 20-05 be rescinded and cancelled in the ordinances of the Parish and that both the 40' and 50' Servitudes of Access in question be considered still of public purpose.

The effective date of this ordinance shall be as prescribed by law.
