## L.P. ORDINANCE NO. 11-34

AN ORDINANCE AMENDING 2011 APPROVED BUDGET AND ADOPTING THE 2012 OPERATING BUDGET OF REVENUES AND EXPENDITURES.

**SECTION 1.** The amended 2011 and the 2012 Operating Budget (as attached) have been adopted as follows:

**SECTION 2**. The amendment of the 2011 approved budget and adoption of the 2012 Operating Budget of Expenditures is declared to be an appropriation of funds as set forth in the budget classifications and that all appropriations lapse at each year end.

**SECTION 3**. Amounts are available for expenditure only to the extent included within this budget.

**SECTION 4.** The Parish President is hereby authorized to make line item adjustments during fiscal year 2012 of expenditures within a functional department. Such adjustments are to be reported to the Parish Council. To the extent actual expenditures exceed the amount appropriated by 5% or more in an individual fund, the Parish President will recommend a budget amendment to the Parish Council for approval as required by the Louisiana Local Government Budget Act, La. R.S. 39:1311.

Whereas, said proposed budget was duly set, after proper notice to the public, for public hearing which was held on December 8, 2011 as required by the Louisiana Local Government Budget Act, 39:1307.

Whereas, the Livingston Parish Council has reviewed and considered such proposed budget and made revisions of same.
