AN ORDINANCE TO AMEND CHAPTER 15, "SOLID WASTE," ARTICLE III, "LICENSING", BY AMENDING SECTION 15-61, "LICENSING", PART (E), "FEE, TERM AND TRANSFERBILITY" OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on Thursday, September 27, 2012, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice was brought up for final passage October 25, 2012, on Motion of Jim Norred and seconded by Joan Landry:

## L.P. ORDINANCE 12-38

AN ORDINANCE TO AMEND CHAPTER 15, "SOLID WASTE," ARTICLE III, "LICENSING", BY AMENDING SECTION 15-61, "LICENSING", PART (E), "FEE, TERM AND TRANSFERBILITY" AND PART (F), "LICENSE DECAL" OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, on February 13, 1997, the Livingston Parish Council adopted L.P. Ordinance 96-40, establishing Chapter 15, Solid Waste, of the Code of Ordinances; and

WHEREAS, the Livingston Parish Council now desires to make further amendments to the Solid Waste ordinance,

THEREFORE, BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana:

SECTION 15-61, GENERAL LICENSING REGULATIONS, of ARTICLE III of CHAPTER 15, PART (E), "FEE, TERM AND TRANFERABILITY", of the Code of Ordinances is hereby amended as follows by deleting and adding the following:

Section 15-61

(e) Fee, term and transferability.

The fee for said license shall be the sum of one hundred dollars (\$100.00) per year for each vehicle permitted, in addition to the annual occupation license fee. The applicant shall obtain and receive, for any vehicle operated in and engaged in the collection of solid waste, a separate permit. The fee shall be paid in advance and the license shall be valid on receipt of that payment form its issuance, but must be renewed no later than January 1 of each successive ear annually thereafter. A license may not be transferred.

BE IT FURTHER ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana:

SECTION 15-61, GENERAL LICENSING REGULATIONS, of ARTICLE III of CHAPTER 15, PART (F), "LICENSE DECAL", of the Code of Ordinances is hereby amended as follows by deleting and adding the following:

(f) License decal.

Each licensee shall permanently affix the license decal issued by the parish on the driver's side door, bottom left corner of the applicable vehicle.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
