L. P. ORDINANCE NO. 11-04

AN ORDINANCE TO DECLARE CERTAIN MOVABLE PROPERTY (EQUIPMENT) NO LONGER NEEDED FOR PUBLIC PURPOSES; PROVIDE FOR ITS SALE BY SEALED BID; AND PROVIDE FOR TERMS OF SALE.

BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana, pursuant to Louisiana Revised Statutes 33:4711, et seq; that:

SECTION 1. The following movable property (equipment) owned by Parish of Livingston, is hereby deemed no longer needed for public purposes and is authorized to be sold at public auction, to wit:
