WHEREAS, a certain parcel of ground is available for sale located at the aforementioned location in Livingston Parish, Louisiana; and

WHEREAS, this parcel of property would be used for a well site as part of a Louisiana Community Development Block Grant Project that the parish has received from the State of Louisiana and the U.S. Department of Housing and Urban Development.

Be it Further Ordained that the purchase price for said property shall be Twenty-Two Thousand and No/100 (\$22,000) Dollars.
