AN ORDINANCE TO AMEND THE LIVINGSTON PARISH CODE OF ORDINANCES CHAPTER 2 SECTION 9-3 (3) “CONTRACTS” BY ADDING A REQUIREMENT GOVERNING CONTRACTS OVER TEN THOUSAND DOLLARS (\$10,000).

WHEREAS, the Livingston Parish Council, as governing authority of the Parish of Livingston, State of Louisiana, adopted L.P.O. 10-02, “Amending and Supplementing Chapter 2 of the Code of Ordinances of Livingston Parish by rescinding Section 2-9.3 and reinstating that section to be titled “Council Policy;” and

WHEREAS, the Livingston Parish Council wishes to provide contractual safeguards to protect the interest of the Parish,

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana, Chapter 2, Section 2-9.3 (3) (c) of the Code of Ordinances of the Parish of Livingston, Louisiana, is hereby amended by adding the following:

- 2-9.3(3)
- c. Contracts
 - 3. All contracts for the parish in an aggregate amount over ten thousand dollars (\$10,000) shall be sent by the President’s office to the official legal counsel of the parish for review.
