## L.P. ORDINANCE NO. 13-10

## AN ORDINANCE ADOPTING THE AMENDED 2013 OPERATING BUDGET OF THE LIVINGSTON PARISH COUNCIL RELATIVE TO THE GENERAL FUND, SPECIAL REVENUE FUNDS, DEBT SERVICE FUNDS, ENTERPRISE FUND AND CAPITAL IMPROVEMENT FUNDS

WHEREAS, in accordance with Section 5-04 of the Home Rule Charter, the Parish President hereby certifies that there are available for appropriation funds in excess of those estimated in the operating budget; and

WHEREAS, the Parish President hereby presents supplements to the budget for the disposition of such funds; and

WHEREAS, in accordance with Section 5-04 of the Home Rule Charter, the Parish president suggests certain reductions in appropriations subject to applicable limitations.

THEREFORE, BE IT ORDAINED by the Livingston Parish Council, governing authority of Livingston Parish, State of Louisiana, convened in legal session, that the 2013 Budget of the Livingston Parish President-Council for the fiscal year beginning January 1, 2013, and ending December 31, 2013, is hereby amended by title as if set out herein in full as follows:

SECTION 1. The amended detailed estimate of Revenues for the fiscal year beginning January 1, 2013, and ending December 31, 2013, be and the same is hereby adopted to serve as an Operating Budget of Revenues for the President-Council during the same period.

SECTION 2. The amended estimates of Expenditures for the fiscal year beginning January 1, 2013, and ending December 31, 2013, be the same is hereby adopted to serve as a budget of Expenditures for the President-Council during the same period.

SECTION 3. The adoption of the amended budget of expenditures be and the same is hereby declared to operate as an appropriation of the amount herein set forth within the terms of the budget classifications.

SECTION 4. Amounts are available for expenditures only to the extent included within the 2013 budget.

SECTION 5. Any additional adjustment made to the budget during the fiscal year should adhere to regulations set forth in Section 5-04 of the Livingston Parish Home Rule Charter.

BE IT FURTHER ORDAINED that this ordinance shall become effective upon adoption by the Livingston Parish Council and signature of the Parish President and all previous ordinances or resolution in conflict with said ordinance are hereby repealed.

BE IT FURTHER ORDAINED that copies of this amended budget be available for public inspection in the office of the Livingston Parish Council.

The above and foregoing addition to the Code of the Parish of Livingston has been read in full, section by section, and was thereupon submitted to a vote; the vote thereon was as follows:
