AN ORDINANCE TO AMEND CHAPTER 13, “PLANNING AND DEVELOPMENT,” SECTION 13-45, “DEFINITIONS”, AND SECTION 13-66, “DEFINITIONS”, OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

L.P. ORDINANCE 13-12

AN ORDINANCE TO AMEND CHAPTER 13, "PLANNING AND DEVELOPMENT," SECTION 13-45, "DEFINITIONS", AND SECTION 13-66, "DEFINITIONS", OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P.O. 01-16, reenacting Chapter 13 of the Code of Ordinances of Livingston Parish, Subdivision Regulations, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 13 of the Code of Ordinances and now desires to further amend those sections defining "mobile home park" and waiver provisions thereto.

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the definition of Mobile Home Park contained in Article IV. SUBDIVISION REGULATIONS, of the Code of Ordinances of Livingston Parish, Section 13-45. *Definitions*, is hereby amended to read as follows:

Mobile Home Park: More than one (1) mobile home located on the same tract of land occupying such space as required by this division. However, if a landowner makes application with the Planning Department and meets the requirements of the affidavit attached hereto and executed, then placement of three (3) mobile homes on the same tract of land, excluding the homestead, will be permitted by the Planning Department.

BE IT FURTHER ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the definition of Mobile Home Park contained in Article IV. SUBDIVISION REGULATIONS, of the Code of Ordinances of Livingston Parish, Section 13-66, is hereby amended to read as follows:

Mobile Home Park: More than one (1) mobile home located on the same tract of land occupying such space as required by this division. However, if a landowner makes application with the Planning Department and meets the requirements of the affidavit attached hereto and executed, then placement of three (3) mobile homes on the same tract of land, excluding the homestead, will be permitted by the Planning Department.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
