AN ORDINANCE AMENDING CHAPTER 9 OF THE LIVINGSTON PARISH CODE OF ORDINANCES, BY AMENDING SECTION 9-223, "LIVINGSTON PARISH CAPITAL IMPROVEMENTS PROCEDURE MANUAL DESIGN AND CONSTRUCTION," BY REPEALING THE 2012 EDITION AND ADOPTING THE LIVINGSTON PARISH CAPITAL IMPROVEMENTS PROCEDURE MANUAL DESIGN AND CONSTRUCTION, 2013 EDITION AS FOLLOWS:

WHEREAS, the Livingston Parish Council, as governing authority of the Parish of Livingston, State of Louisiana desires to amend the Livingston Parish Capital Improvements Procedures Manual for Design and Construction, 2012 Edition; and

WHEREAS, the Livingston Parish Council desires to omit and revise certain portions that would require Council approval to become a part of the ordinary authority of the Parish President; and

WHEREAS, the Livingston Parish Council now desires to add Article 17: Contracts to the Livingston Parish Capital Improvements Procedure Manual Design and Construction;

WHEREAS, the Livingston Parish Council desires to amend certain language its legal counsel has recommended be amended for the sake of accuracy on behalf of the Parish;

THEREFORE BE IT ORDAINED by the Livingston Parish Council that Section 9-223 of the Code of Ordinances of the Parish of Livingston, State of Louisiana is hereby amended by adopting a revised version entitled, "Livingston Parish Capital Improvements Procedure Manual Design and Construction, 2013 Edition:

SECTION 9-223 Capital Improvements Procedure Manual for Design and Construction.

A copy of the Livingston Parish Capital Improvements Procedure Manual for Design and Construction, 2013 Edition must be obtained and strictly adhered to for conducting business with the parish pursuant to capital improvements

Copies of the manual are obtained through the Livingston Parish Council Office.

THEREFORE, BE IT ORDAINED that the Livingston Parish Council adopt said procedure manual.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

The effective date of this ordinance shall be as prescribed by law.
