AN ORDINANCE SETTING THE MILLAGE RATES AS ADJUSTED FOR THE TAX YEAR 2013

BE IT ORDAINED by the Livingston Parish Council, governing authority of the PARISH OF Livingston, State of Louisiana, in a public meeting held on August 8, 2013, which meeting was conducted in accordance with the Open Meetings Law, and the additional requirements of Article VII, Section 23 (C) of the Louisiana constitution and Louisiana Revised Statutes 47:1705 (B), et seq. and pursuant to Section 2-11 A(3) of the Home Rule Charter of the President-Council, that the following adjusted millage rates be and they are hereby levied upon the dollar of the assessed valuation of all taxable property subject to ad valorem taxation within said Parish for the year 2013, for the purpose of raising revenue: Said millages are:
