NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on August 22, 2013 and laid over for publication of notice:

LIVINGSTON PARISH ORDINANCE NO. 13-36

AN ORDINANCE TO AMEND L.P. ORDINANCE 13-09 BY REMOVING “PARKWAY DRIVE AND TIMBERLAKE DRIVE (BOTH INTERSECTIONS)”, AND ALSO REMOVING THE THREE WAY STOP INTERSECTION AT “CANTERBURY AND PENBROOKE AVENUE” AND ADDING A THREE WAY STOP AT THE INTERSECTION OF “CANTERBURY AND NEWPORT DRIVE”.

The following ordinance, which was previously introduced in written form at a regular meeting of the Parish Council on August 22, 2013, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage September 12, 2013, on motion of Sonya Collins and seconded by Joan Landry.

LIVINGSTON PARISH ORDINANCE NO. 13-36

AN ORDINANCE TO AMEND L.P. ORDINANCE 13-09 BY REMOVING “PARKWAY DRIVE AND TIMBERLAKE DRIVE (BOTH INTERSECTIONS)”, AND ALSO REMOVING THE THREE WAY STOP INTERSECTION AT “CANTERBURY AND PENBROOKE AVENUE” AND ADDING A THREE WAY STOP AT THE INTERSECTION OF “CANTERBURY AND NEWPORT DRIVE”.

SECTION 1. Chapter 10 of the Code of Ordinances in and for the Parish of Livingston, “Motor Vehicles and Traffic,” contains a section, more specifically Section 10-9(a), designating specific intersections as three-way stops and ordering the installation of stop signs.

SECTION 2. La. R.S. 32:42 authorizes local parish authorities to adopt ordinances to regulate, designate, direct and restrict vehicular traffic on highways other than state maintained highways and with respect to public roads within their territorial limits, but outside corporate limits of any municipality therein.

SECTION 3. Be it ordained by the Livingston Parish Council that L.P. Ordinance 13-09, adopted on April 11, 2013, Section 10-9(a) of the Code of Ordinances of the Parish of Livingston, State of Louisiana, is hereby amended by removing the intersections of :

Canterbury Avenue and Penbrooke Avenue

Parkway Drive and Timberlake Drive (Both intersections)

And adding the intersection:

Canterbury Avenue and Newport Drive

SECTION 4. The effective date of this ordinance shall be as prescribed by law.

SECTION 5. The above and foregoing addition to the Code of the Parish of Livingston, having been properly introduced and published by title, was thereupon submitted to a vote; the vote thereon was as follows:
