NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on October 10, 2013, and laid over for publication of notice:

LIVINGSTON PARISH ORDINANCE NO. 13-38

AN ORDINANCE REVOKING A 10' STRIP PORTION OF AN EXISTING 15' UTILITY SERVITUDE ACROSS LOT 39, LOT 40, LOT 69 & LOT 70, WYNDHAM ESTATES SUBDIVISION, 2ND FILING, LOCATED IN SECTIONS 20, 21 & 28, T6S-R3E, LIVINGSTON PARISH, LOUISIANA, IN FAVOR OF THE LAND OWNER, BEING MORE PARTICULARLY DESCRIBED ON THE ATTACHED PLAT.

AN ORDINANCE REVOKING A 10’ STRIP PORTION OF AN EXISTING 15’ UTILITY SERVITUDE ACROSS LOT 39, LOT 40, LOT 69 & LOT 70, WYNDHAM ESTATES SUBDIVISION, 2ND FILING, LOCATED IN SECTIONS 20, 21 & 28, T6S-R3E, LIVINGSTON PARISH, LOUISIANA, IN FAVOR OF THE LAND OWNER, BEING MORE PARTICULARLY DESCRIBED ON THE ATTACHED PLAT.

WHEREAS, by the official plat of MAP SHOWING THE REVOCATION OF A 10’ STRIP PORTION OF AN EXISTING 15’ UTILITY SERVITUDE ACROSS LOT 39, LOT 40, LOT 69 & LOT 70, OF WYNDHAM ESTATES SUBD., 2ND FILING, LOCATED IN SECTIONS 20, 21 & 28, T6S-R3E, G.L.D., LIVINGSTON PARISH, LOUISIANA FOR CALVIN BLOUNT, by Alvin Fairburn & Associates, LLC, dated September 10, 2013, recorded as Plat Book Entry _____ in the office of the Clerk and Recorder for the Parish of Livingston, State of Louisiana, attached hereto and made a part hereof by reference, is located a 15’ utility servitude across Lot 39, Lot 40, Lot 69 & Lot 70, Wyndham Estates Subdivision, 2nd Filing.

WHEREAS, a petition has been addressed to the Livingston Parish President-Council by Calvin L. Blount, as the current owner of the 10’ strip portion of the existing 15’ utility servitude across Lot 39, Lot 40, Lot 69 & Lot 70, Wyndham Estates Subdivision, 2nd Filing, requesting the revocation of said servitude.

WHEREAS, the Livingston Parish President-Council is of the opinion that the 10’ strip portion of the existing 15’ utility servitude across Lot 39, Lot 40, Lot 69 & Lot 70, Wyndham Estates Subdivision, 2nd Filing, as described above, is not needed for public purposes.

BE IT ORDERED by the Livingston Parish President-Council, acting in accordance with R.S. 48:701, the 10’ strip portion of the existing 15’ utility servitude across Lot 39, Lot 40, Lot 69 & Lot 70, Wyndham Estates Subdivision, 2nd Filing, is hereby revoked and set aside.

The effective date of this ordinance shall be as prescribed by law.
