NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on October 24, 2013, and laid over for publication of notice:

L. P. ORDINANCE NO. 13-41

AN ORDINANCE AMENDING SECTION 14-174 OF THE LIVINGSTON PARISH CODE OF ORDINANCES TO PROVIDE FOR THE ALTERATION OF THE EXISTING BOUNDARIES OF THE LIVINGSTON PARISH SPECIAL TAXING DISTRICT NO. 5 **AND THE LIVINGSTON PARISH GRAVITY DRAINAGE DISTRICT NO. 5** AS SET FORTH IN LIVINGSTON PARISH ORDINANCE 04-08.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on October 24, 2013, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage November 14, 2013, on Motion of Ricky Goff and seconded by Ronnie Sharp:

L. P. ORDINANCE NO. 13-41

AN ORDINANCE AMENDING SECTION 14-174 OF THE LIVINGSTON PARISH CODE OF ORDINANCES TO PROVIDE FOR THE ALTERATION OF THE EXISTING BOUNDARIES OF THE LIVINGSTON PARISH SPECIAL TAXING DISTRICT NO. 5 **AND THE LIVINGSTON PARISH GRAVITY DRAINAGE DISTRICT NO. 5** AS SET FORTH IN LIVINGSTON PARISH ORDINANCE 04-08.

**WHEREAS**, the Board of Commissioners of the Livingston Parish Special Taxing District No. 5 and the Livingston Parish Gravity Drainage District No. 5, has deemed it necessary and desirable to alter the boundaries of Livingston Parish Special Taxing District No. 5 **and Livingston Parish Gravity Drainage District No. 5** as set forth by Livingston Parish ordinance 04-08; and passed a resolution setting forth the new boundaries;

WHEREAS, the Livingston Parish Council has general power over any agency created by it, including the power to amend the boundaries of special taxing districts and the drainage districts, pursuant to Section 15, Article 6 of the Louisiana Constitution of 1974;

**NOW, THEREFORE, BE IT ORDAINED**, by the **LIVINGSTON PARISH COUNCIL**, of Livingston Parish, Louisiana, as follows:

SECTION 1. That Section 14-174 of the Livingston Parish Code shall be amended to change the boundaries of the Livingston Parish Special Taxing District No. 5 **and Livingston Parish Gravity Drainage District No. 5** as set forth in Livingston Parish ordinance 04-08, said legal description of the Special Taxing District No. 5 to be:

**Legal Description — Livingston Parish Special Taxing District No. 5 and Livingston Parish Gravity Drainage District No. 5**

Commencing at a point which is the intersection of the centerline 1-12 Interstate Highway and the centerline of Hornsby Creek; thence proceed in a southerly direction along the centerline of said creek to the centerline of Colyell Creek; thence along said centerline in a southerly direction to the north line of Section 22, Township 7 South, Range 4 East; thence in a western direction along the north line of Sections 22, 21, 20 and 39, Township 7 South, Range 4 East; thence west along the south line of Sections 13 and 14, Township 7 South, Range 3 East to the southwest corner of Section 14, Township 7 South, Range 3 East; thence north along the west line of Section 14 to its northwest corner; thence west along the south line of Section 10, Township 7 South, Range 3 East; thence north along the west line of Section 10, to its intersection with the centerline of the Buddy Ellis Road; thence west along said centerline of the Buddy Ellis Road to a line which runs south from the intersection of the south line of Section 16, township 6 South, Range 3 East and the projection of the centerline of Dunn Road; thence north along said line to the intersection of the south line of Section 16, Township 6 South, Range 3 East and the projection of the centerline of Dunn Road; thence north along the centerline of said Dunn Road to its intersection with Arnold Road (State Hwy 1025); and thence north to the south line of Section 4, Township 6 South, Range 3 East; thence in an eastern direction along the south line of sections 4,3, and 2, Township 6 South Range 3 East, to the intersection of the south line of section 2 with the centerline of West Colyell Creek; thence in a northern direction along the centerline of West Colyell Creek to the centerline of Cane Market Road; thence in an eastern direction along the centerline of Cane Market Road to the centerline of Middle Colyell Creek; thence in a southern direction along said centerline to the north line of Section 19, Township 6 South, Range 4 East; thence east along the north line of Sections 19 and 20, Township 6 South, Range 4 East; to a line which is 300 feet east of and parallel to State Highway 449 (North Corbin Road); **thence** along said line in a southerly direction to its intersection with the northern corporate limits of the City of Walker; thence

proceed easterly along the north boundary line of the J.H. Jenkins property and Section 29, Township 6 South, Range 4 East to the northwest corner of the Industrial Park Property; thence easterly along the northern boundary of the Industrial Park Property to the northeast corner of the Industrial Park Property; thence southerly along the east boundary of the Industrial Park Property to the southern right of way of U.S. Highway 190 to the corporate limits of the City of Walker; thence in a southerly direction along said line to the corporate limits of the City of Walker, thence west along the corporate limits of the City of Walker to the centerline of Middle Colyell Creek; thence in a southern direction along said centerline to the centerline of I-12 Interstate Highway; thence in a easterly direction along said centerline to its intersection with Hornsby Creek and point of beginning.

SECTION 2. That this ordinance, being retroactive in nature, shall have effect as of November 14, 2013.

This ordinance having been submitted to a vote, the vote thereon was as follows:
