BE IT ORDAINED by the Livingston Parish Council, Parish of Livingston, State of Louisiana: The Code of Ordinances of the Parish of Livingston, Louisiana, is hereby amending the following pursuant to the Tickfaw River at Highway 22 Bridge (Rome's Ferry Bridge):

Sec. 11–2 Speed of Boats

Tickfaw River at Highway 22 Bridge (Rome's Ferry Bridge). Upstream from Rome's Ferry Bridge to the "Y," then Northwest to Tickfaw River to complete three hundred (300) feet, and Northeast to Blood River to complete three hundred (300) feet; and from the Rome Ferry Bridge, downstream until 300 feet south of the dock at Tin Lizzie's.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
