LIVINGSTON PARISH ORDINANCE NO. 14-04

AN ORDINANCE REVOKING THE NORTHERN 235.59’ OF THE EXISTING 40’ RIGHT-OF-WAY OF LEE DRIVE LOCATED IN SECTION 26, TOWNSHIP 6 SOUTH, RANGE 3 EAST, LIVINGSTON PARISH, LOUISIANA, BEING MORE PARTICULARLY DESCRIBED ON THE ATTACHED SKETCH.

WHEREAS, by the MAP SHOWING SKETCH OF LEE DRIVE RIGHT-OF-WAY, LOCATED IN SECTION 26, T6S-R3E, G.L.D., LIVINGSTON PARISH, LOUISIANA FOR JENNIFER HOMES, by Alvin Fairburn & Associates, LLC, attached hereto and made a part hereof by reference, is a portion of the 40’ right-of-way of Lee Drive.

WHEREAS, a petition has been addressed to the Livingston Parish President-Council by the Livingston Parish Planning and Zoning Department, as the current owner of the northerly 235.59’ of the 40’ right-of-way of Lee Drive, requesting the revocation of said portion of the Lee Drive right-of-way.

WHEREAS, the Livingston Parish President-Council is of the opinion that the northern 235.59’ of the 40’ right-of-way of Lee Drive, is not needed for public purposes.

BE IT ORDERED by the Livingston Parish President-Council, acting in accordance with R.S. 48:701, the northern 235.59’ of the 40’ Lee Drive right-of-way, is hereby revoked and set aside.

The effective date of this ordinance shall be as prescribed by law.
