### L.P. ORDINANCE 14-05

AN ORDINANCE TO AMEND BY ADDING TO THE LIVINGSTON PARISH CODE OF ORDINANCES CHAPTER 2 SECTION 9-3 SUBSECTION (3) “CONTRACTS” A REQUIREMENT GOVERNING CONTRACTS OVER TEN THOUSAND DOLLARS (\$10,000).

The following ordinance which was previously introduced in written form at a regular meeting of the Parish Council on March 13, 2014, a Notice of Public Hearing having been published in the official journal and which public hearing was held in accordance with said public notice, was brought up for final passage on April 10, 2014 on motion of Jim Norred duly seconded by Marshall Harris:

AN ORDINANCE TO AMEND THE LIVINGSTON PARISH CODE OF ORDINANCES CHAPTER 2 SECTION 9-3 (3) "CONTRACTS" BY AMENDING A REQUIREMENT GOVERNING CONTRACTS OVER TEN THOUSAND DOLLARS (\$10,000).

WHEREAS, the Livingston Parish Council, as governing authority of the Parish of Livingston, State of Louisiana, adopted L.P.O. 10-02, "Amending and Supplementing Chapter 2 of the Code of Ordinances of Livingston Parish by rescinding Section 2-9.3 and reinstating that section to be titled "Council Policy;" and

WHEREAS, the Livingston Parish Council wishes to provide contractual safeguards to protect the interest of the Parish,

**NOW, THEREFORE, BE IT ORDAINED** by the governing authority of the Parish of Livingston, State of Louisiana, Chapter 2, Section 2-9.3 (3) (c) of the Code of Ordinances of the Parish of Livingston, Louisiana, is hereby amended as follows:

2-9.3(c)

c. Contracts

3. All contracts for the parish in an aggregate amount over ten thousand dollars (\$10,000) shall be sent by the President's office to the legal counsel of the parish for review. Upon completion of his review a copy of the contract and his comments and/or recommendations shall be sent to the Parish Council office.

Upon being subjected to a vote, the vote thereon was as follows:
