LIVINGSTON PARISH ORDINANCE NO. 14-15

BE IT ORDAINED by the Livingston Parish Council, governing authority of the Parish of Livingston, State of Louisiana, pursuant to Louisiana Revised Statutes 33:4711, et. seq; that:
