### **L.P. ORDINANCE 14-19**

AN ORDINANCE TO AMEND CHAPTER 13, “PLANNING AND DEVELOPMENT,” SECTION 13-50, “PROCEDURE FOR SUBDIVISIONS WITHOUT IMPROVEMENTS”, OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

The following ordinance, which was previously introduced in written form required for adoption at a regular meeting of the Parish Council on July 10, 2014, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice was brought up for final passage August 14, 2014, on Motion of Joan Landry and seconded by Jim Norred:

**L.P. ORDINANCE 14-19**

AN ORDINANCE TO AMEND CHAPTER 13, “PLANNING AND DEVELOPMENT,” SECTION 13-50, “PROCEDURE FOR SUBDIVISIONS WITHOUT IMPROVEMENTS”, OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P.O. 01-16, reenacting Chapter 13 of the Code of Ordinances of Livingston Parish, Subdivision Regulations, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 13 of the Code of Ordinances and now desires to further amend subsection C(3), “Wetland Mitigation Plan.”

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the Code of Ordinances of Livingston Parish, Section 13-50 C (3) is hereby amended to read as follows:

*Wetland mitigation plan.* Whether the proposed development contains wetlands or not (determined by the Corps of Engineers) the developer shall submit a letter in writing with associated Corps of Engineer documentation showing proof thereof to the review engineer and the planning director, any wetlands existed within the parish rights-of-way, servitudes, and drainage located in this subdivision additional documentation shall be submitted proving said wetlands have been mitigated.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
