L.P. ORDINANCE 14-20

AN ORDINANCE TO AMEND CHAPTER 13, "PLANNING AND DEVELOPMENT," SECTION 13-54.1, "STREETS AND STANDARDS", OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P.O. 01-16, reenacting Chapter 13 of the Code of Ordinances of Livingston Parish, Subdivision Regulations, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 13 of the Code of Ordinances and now desires to further amend Section 13-54.1 (B) by adding subpart (18) for safety on parish roads.

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the Code of Ordinances of Livingston Parish, Section 13-54.1(B) is hereby amended by adding:

Section 13-54.1

(B)(18) Where a subdivision borders on or contains an existing or proposed roadway, it shall be required for access to such street(s) of said subdivision that lots be platted such that the driveway of said lots connects to the proposed street and not the existing parish street, with exception to Minor Subdivisions.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
