AN ORDINANCE TO AMEND CHAPTER 13, "PLANNING AND DEVELOPMENT," SECTION 13-55, "SERVITUDES: RIGHTS-OF-WAY", OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON.

WHEREAS, the Livingston Parish Council adopted L.P.O. 01-16, reenacting Chapter 13 of the Code of Ordinances of Livingston Parish, Subdivision Regulations, and

WHEREAS, the Livingston Parish Council has adopted numerous amendments to Chapter 13 of the Code of Ordinances and now desires to further amend Section 13-55.

NOW, THEREFORE, BE IT ORDAINED by the governing authority of the Parish of Livingston, State of Louisiana: the Code of Ordinances of Livingston Parish, Section 13-55 is hereby amended by amending subsection (G) as follows:

Section 13-55 Servitudes: rights-of-way

(G) All subdivision/re-subdivision for single family dwellings (with lot sizes of ten thousand (10,000) square feet or less) and multifamily developments consisting of a combined total of twenty (20) lots/units or more, not yet submitted, must include one (1) guest parking space for every three (3) single family lots or multifamily units. These spaces must be separate from the lots and distributed evenly and conveniently located for use throughout the subdivision to the satisfaction of the Review Engineer. The total number of lots shall include all filings.

All ordinances or parts of ordinances in conflict herewith are hereby repealed. If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
