The following ordinance, which was previously introduced in written form at a regular meeting of the Parish Council on November 19, 2015, a summary thereof having been published in the official journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage December 17, 2015, on motion of Joan Landry and seconded by Delos Blackwell:

## LIVINGSTON PARISH ORDINANCE NO. 15-37

## AN ORDINANCE TO AMEND AND REENACT SECTION 10-9(a), "STOP SIGNS, THREE-WAY STOP," OF THE CODE OF ORDINANCES IN AND FOR THE PARISH OF LIVINGSTON, TO ADD THE INTERSECTION AT QUIET CREEK DRIVE AND PLANTATION LAKE AVENUE.

WHEREAS, Chapter 10 of the Code of Ordinances in and for the Parish of Livingston, "Motor Vehicles and Traffic," contains a section, more specifically Section 10-9(a), designating specific intersections as three-way stops and ordering the installation of stop signs.

WHEREAS, La. R.S. 32:42 authorizes local parish authorities to adopt ordinances to regulate, designate, direct and restrict vehicular traffic on highways other than state maintained highways and with respect to public roads within their territorial limits, but outside corporate limits of any municipality therein.

THEREFORE, BE IT ORDAINED by the Livingston Parish Council that Section 10-9(a) of the Code of Ordinances of the Parish of Livingston, State of Louisiana, is hereby amended as follows:

SECTION 1. Add the following intersection to the list of intersections contained in Section 10-9 (a) Three-way stop:

At the intersections of Quiet Creek Drive and Plantation Lake Avenue.
SECTION 2. The effective date of this ordinance shall be as prescribed by law.
SECTION 3. The above and foregoing addition to the Code of the Parish of Livingston, having been properly introduced and published by title, was thereupon submitted to a vote; the vote thereon was as follows:
