NOTICE IS HEREBY GIVEN that the following entitled ordinance was introduced in writing in the form required for adoption at a meeting of the Parish Council of the Parish of Livingston, State of Louisiana, on April 28, 2016, and laid over for publication of notice:

AN ORDINANCE ABANDONING THAT CERTAIN PORTION OF BOSS MCNABB ROAD WITHIN THE PARISH OF LIVINGSTON, STATE OF LOUISIANA, AND MORE PARTICULARLY 2,500 FEET WHICH IS GRAVEL AND UNPAVED

NOTICE IS HEREBY FURTHER GIVEN that the Parish Council of said Parish will meet on May 26, 2016, at six (6:00) o'clock p.m., at the Parish Council Chambers, Governmental Building, 20355 Government Boulevard, Livingston, Louisiana, at which time there will be a public hearing on the adoption of the aforesaid ordinance.

The following ordinance which was previously introduced in written form required for adoption at a regular meeting of the Livingston Parish Council on Thursday, April 28, 2016, a summary thereof having been published in the Official Journal together with a notice of public hearing which was held in accordance with said public notice, was brought up for final passage on June 23, 2016 on Motion of Tracy Girlinghouse and seconded by R.C. "Bubba" Harris:

L.P. ORDINANCE NO. 16-15

AN ORDINANCE ABANDONING THAT CERTAIN PORTION OF BOSS MCNABB ROAD WITHIN THE PARISH OF LIVINGSTON, STATE OF LOUISIANA, AND MORE PARTICULARLY 2,500 FEET WHICH IS GRAVEL AND UNPAVED

WHEREAS, the Livingston Parish Council conducted a public hearing on the proposed abandonment of certain portions of Boss McNabb Road more particularly 2,500 feet which is gravel and unpaved and authorizing said action.

WHEREAS, the Parish of Livingston previously taken 2,592 feet of Boss McNabb Road into the Parish maintenance system.

WHEREAS, 2,500 feet of that road is not paved and does not serve any residents.

WHEREAS, the Parish of Livingston now desires to abandon the maintenance and responsibility for said unpaved, gravel portion of Boss McNabb Road, since it no longer serves a public purpose.

NOW, THEREFORE, BE IT ORDAINED, that the Livingston Parish Council hereby formally abandons the easternmost twenty-five hundred feet (2500') of Boss McNabb Road starting at a point two thousand ninety-two feet (2092') east of Union Landing Road. This abandonment does not include the first two thousand ninety-two feet (2092') immediately East of Union Landing Road.

BE IT FURTHER ORDAINED, that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications which can be given effect without the invalid provision, items, or applications, and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that all ordinances or parts thereof in conflict herewith are hereby repealed.

The effective date of this ordinance shall be as prescribed by law.
