## L.P. ORDINANCE NO. 16-19

AN ORDINANCE AMENDING THE BOUNDARIES OF SEWERAGE DISTRICT NO. 2 OF LIVINGSTON PARISH, LOUISIANA AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

NOTICE IS HEREBY FURTHER GIVEN that the Parish Council of the Parish of Livingston, State of Louisiana will meet on Thursday, June 23, 2016, at 6:00 p.m., at the Council Chambers in the Governmental Building, 20355 Government Blvd., Livingston, Louisiana, at which time there will be a public hearing on the adoption of the aforesaid ordinance.

The following Ordinance which was previously introduced in written form at a regular meeting of the Parish Council on May 26, 2016, a Notice of Public Hearing having been published in the official journal and which public hearing was held in accordance with said public notice, was offered by Garry "Frog" Talbert and seconded by Maurice "Scooter" Keen:

## L.P. ORDINANCE NO. 16-19

AN ORDINANCE AMENDING THE BOUNDARIES OF SEWERAGE DISTRICT NO. 2 OF LIVINGSTON PARISH, LOUISIANA AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, pursuant to the authority set forth in Sub-Part A, Part I, Chapter 9 of Title 33 of the Louisiana Revised Statutes of 1950, as amended and the Livingston Parish Home Rule Charter, the Parish Council of the Parish of Livingston, State of Louisiana, acting as governing authority of the Parish of Livingston, State of Louisiana (the "Council") created Sewerage District No. 2 of Livingston Parish, Louisiana (the "District") by an Ordinance adopted on April 26, 1975, as amended on March 10, 2016 (the "Boundary Ordinance"); and

WHEREAS, the Council may alter the boundaries of the District, upon their own initiative under Sub-Part A, Part I, Chapter 9 of Title 33 of the Louisiana Revised Statutes of 1950, as amended; and

WHEREAS, the aforementioned boundary change will not cause an impairment of the obligations of any contract of the District; and

WHEREAS the District's initial boundaries were established by the Boundary Ordinance and are presently described in Section 17-66 of the Livingston Parish Code of Ordinances; and

WHEREAS, the Parish and the District have identified a need to expand boundaries of the District to better serve the Parish's residents; and

WHEREAS the additional area that is to be added to the District is specifically described as follows: "Beginning at the intersection of the centerline of West Colyell Creek and Interstate 12 southern right-of-way line; thence in a westerly direction along Interstate 12 southern right-of-way to the intersection of the Interstate 12 southern right-of-way line and the east section line of Section 2; thence in a southerly direction along the east section line of Section 2, continuing in a southerly direction along the east section line of Section 11 to the intersection of the east section line of Section 11 and the centerline of Buddy Ellis Road; thence in a westerly direction along the centerline of Buddy Ellis Road to the intersection of the centerline of Buddy Ellis Road and the centerline of West Colyell Creek; thence in a northerly direction along the centerline of West Colyell Creek to the intersection of the centerline of West Colyell Creek and the southern right-of-way line for Intestate 12."

NOW, THEREFORE, BE IT ORDAINED by the Parish Council of the Parish of Livingston, State of Louisiana, as the governing authority of the Parish of Livingston, State of Louisiana, that:

SECTION 1. Section 17-66 of the Livingston Parish Code of Ordinances shall be amended to read as follows:

"Pursuant to the authority conferred by Sub-Part A of Part 1 of Chapter 9 of Title 33 of the Louisiana Revised Statutes of 1950, and other applicable laws, there is hereby amended the boundary of Sewer District No. 2 within the Parish of Livingston, State of Louisiana, comprising and embracing all of that territory within the following described boundaries, to wit:

Commence at a point where the Livingston and St. Helena Parish line intersects the centerline of the Amite River; thence, east along said parish line to the NE corner of Section 1, T5S, R4E; thence, south along the section line to the SE corner of Section 1, T6S, R4E; thence west along the section line to the SW corner of Section 4, T6S. R4E; thence, south along the section line to the SE corner of Section 8, T6S, R4E; thence, west along the section line to the SW corner of Section 7, T6S, R4E to the point of beginning; thence, south along the section line to the SE corner of Section 24, T6S, R3E; thence, west along the section line to the SW corner of said section; thence, south along the section line to a point where the northern margin of the right-of-way of the Canadian Northern Railroad (formerly Illinois Central Gulf Railroad) intersect the said section line; thence, proceed in a westerly direction along the northern margin of the Canadian Northern Railroad (formerly Illinois Central Gulf Railroad) right-of-way to the east bank of West Colyell Creek, thence proceed in a southerly direction along the eastern bank West Colyell Creek, to a point of intersection at the southern right-of-way of Interstate 12; From the intersection of the centerline of West Colyell Creek and Interstate 12 southern right-of-way line; thence in a westerly direction along Interstate 12 southern right-of-way to the intersection of the Interstate 12 southern right-of-way line and the east section line of Section 2; thence in a southerly direction along the east section line of Section 2, continuing in a southerly direction along the east section line of Section 11 to the intersection of the east section line of Section 11 and the centerline of Buddy Ellis Road; thence east along the centerline of Buddy Ellis Road to the intersection of Louisiana Highway 447 (Walker South); thence, south along the centerline of Louisiana Highway 447 to the intersection of the centerline of Middle Colyell Lateral, known as Pendarvis Creek, thence in a southerly direction along the centerline of said lateral to the intersection with the centerline of Middle Colyell Creek; thence in a southerly direction along said creek to the point of intersection with the south section line of Section 4, T8S, R4E; thence west along said section line to the northeast corner of Section 7, T8S, R4E; thence south along the east line of Section 7 to the northern section line of Section 62, T8S, R4E; thence clockwise around Section 62 to the intersection with the Range Line common to Ranges 3 and 4 East, located at the northeast corner of Section 42, T8S, R3E; thence southwest along the northwest section line of Section 42, T8S, R3E to a point located 1000' from the centerline of La. Hwy, 16 along section line of Section 42 T8S, R3E; thence in a northwesterly direction on a meandering line, which line is at all points located 1000' from, parallel to the centerline of La, Hwy.

16 to a point located upon the eastern right-of-way line of La Hwy. 447; thence southwest along the eastern right-of-way of La. Hwy. 447 to a point of intersection of the said right-of-way and the extension of the southern right-of-way of Carolyn Drive across La. Hwy 447; thence northwesterly across La. Hwy. 447, aligned with the southern right-of-way of Carolyn Drive a distance of 284.7' to a point along said right-of-way; thence South 29°35'00" West along the west lot line of Lot No.8 of the Scivicque Place Subdivision to a point located 438' from Carolyn Drive right-of-way along said bearings, this point is the northwest corner of Lot No.6 of the Scivicque Place Subdivision; thence North 63°29'00" West along lot line between Lots No. 9 and Lot No. 6 of the Scivicque Place Subdivision to a point located 200.5' from the northwest corner of Lot No.6 along said bearings; thence South 13°22'00" West along lot line between Lot No.5 and Lot No. 6 of the Scivicque Place Subdivision Drive a distance of 490' to a point along said bearings at the centerline of La. Hwy. 16; thence approximately 160' in a south westerly direction along the centerline of La. Hwy. 16; thence South 18°00'00" West, a distance of approximately 258' from the centerline of La. Hwy. 16 along said bearings; thence south a distance of approximately 174.60' along said bearings; thence North 74°16'31" West, a distance of approximately 192.06' along said bearings; thence South 18°21'24" West, a distance of approximately 252.12' along said bearings; thence North 71°38'36" West, a distance of approximately 242.71' along said bearings; thence South 00°14'10" West, a distance approximately 1037.34' along said bearings; thence in a northeasterly direction along Willis Bayou Swamp, a distance of approximately 794.4'; thence southeasterly on a meandering line, which line is at all points located 1000' from, parallel to, and southwesterly of the centerline of La. Hwy.16 to a point along the section line of Section 42, T8S, R3E; thence in a southwesterly direction along section line of Section 42, T8S, R3E to the centerline of Grays Creek; thence north and northwest up the centerline of Grays Creek to the intersection with Scivicque Road; thence northeast along the centerline of Scivicque Road to the intersection of the northeast right-of-way line of Louisiana State Highway Number 16, located in Section 44, T8S, R3E; thence in a northwesterly direction along Highway 16 right-of-way line to the intersection of the south section line of Section 48, T7S, R3E; thence in a northeasterly direction along said section line to the southwest corner of the east ½ of Section 48, T7S, R3E; thence in a northwest direction along the ½ section line to the northwest corner of the east ½ of section 48, T7S, R3E; thence northeast along said section line to the southeast corner of Section 27, T7S, R3E; thence north along the said section line to the northeast corner of Section 27; thence west along said section to the southwest corner of Section 22, T7S, R3E; thence north along said section line to the southeast corner of the northeast ¼ of Section 21, T7S, R3E; thence north along said \( \frac{1}{4} \) section line to the northwest corner of the northeast \( \frac{1}{4} \) of Section 21, T7S, R3E; thence west to the southwest corner of Section 39, T7S, R3E; thence north along the section line to the northwest corner of said section; thence west along the section line to the southwest corner of Section 5, T7S, R3E; thence, north along the section line to the northeast corner of Section 37, T7S, R3E; thence, west along section line to the southeast corner of Section 6, T7S, R3E; thence north along the section line to the southwest corner of Section 32, T6S, R3E;

thence, east along the section line to the southeast corner of Section 32, T6S, R3E; thence, north along the section line to the north east corner of Section 45, T6S, R3E; thence, west along the section line to the intersection of the said section line with the eastern boundary of the corporate limits of Denham Springs; thence, along the corporate limit boundary in a counterclockwise direction to a point being the intersection of the northern boundary of Section 59, T6S, R2E, and the centerline of the Amite River; thence, in a northerly direction along of the centerline or the meanderings of the Amite River to the point of beginning, all as more fully shown on a map showing District Boundary. Commencing at the southwest corner of section 19, T6S, R3E; thence north along said section line to the northeast corner of section 43, T6S, R3E; thence west along said section line to the intersection of said section line with the centerline of Colton Creek; thence in a northeasterly direction along the centerline of Colton Creek with the north line of Section 41, T6S, R3E; thence in an easterly direction along the north line of said section 41 to the north east corner of said section 41, T6S, R3E; thence south along the east line of said section 41 to the northwest corner of Section 20, T6S, R3E; thence in an easterly direction along the north line of said section 20 to the northeast corner of said section 20, said corner also being the southeast corner of section 17, T6S, R3E; thence north along the east line of said section line to the northwest corner of section 9, T6S, R3E; thence east along the section line to the northwest corner of section 7, T6S, R4E; thence south along the section line to the southeast corner of section 24, T6S, R3E; back to the point of beginning."

SECTION 2. All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 3. If any provision of this Ordinance is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance, which can be given effect without the invalid provision, or application, and to this end the provision of this Ordinance are hereby declared severable.

SECTION 4. The Chairman and Council Clerk of the Council, along with the Parish President, are further authorized and directed to do any and all things necessary and incidental to carry out the provisions of this Ordinance.
