MINUTES

Livingston Parish April 14, 2022

Pursuant to notice duly posted in the public lobby of the Livingston Parish Governmental Building, the Livingston Parish Ordinance Committee met on April 14, 2022, at the hour of four thirty o'clock (4:30) p.m. in the Parish Council Chambers, located in the Livingston Parish Governmental Building, 20355 Governmental Boulevard, Livingston, Louisiana with the following members present:

The Chairman, Councilman John Wascom, called the meeting to order.

The Chair began by addressing Old Business, item 3a, "Ordinance establishing authority to the Livingston Parish School Board regarding impact studies – Tracy Girlinghouse".

Having no business, the chair then addressed item 3b, "An ordinance that would mandate that fill dirt could not be added over one (1) foot on an acre or less in parts of the Parish south of the interstate – Gerald McMorris".

The chair announced that item is being pulled by request of Councilman McMorris.

The Chair then addressed item 3c, "Amend Chapter 125, amend various sections of Chapter 125, "Subdivision Regulations" to ensure that any alterations to project designs are up to date with the current standards to reduce drainage issues and prevent flooding - Garry Talbert".
