WHEREAS, this parish is projected to continue to be the fastest growing Parish in the State Highway infrastructure improvements in this parish are needed badly;

WHEREAS, the proposed project does not meet that need and other studies that have been conducted show greater positive impacts to our traffic issues at only a fraction of the cost of this proposed project, whereby the Hooper Road extension is an example;

WHEREAS, the citizens of Livingston Parish have long opposed the Baton Rouge Loop;

WHEREAS, the Livingston Parish Council member represent these citizens;

WHEREAS, the members of the Livingston Parish Council oppose this project based on the following requirements noted in the Baton Rouge Loop Implementation Plan:

- Local infrastructure will be disturbed including roads, utilities, sewage and the parish will have the responsibility of addressing these and the dollar cost will be high and the disruption will create hardships on our citizens.
- Local transportation routes will be negatively altered causing increased cost to the school system and individual citizens.
- The parish is given responsibility to maintain the corridor once it is chosen; Livingston Parish will not accept that responsibility.
- There is a "non-compete" clause. Highways added in the future by the state or parish, which is deemed to reduce toll traffic on the Loop, will require those public entities to compensate the Loop operation.
- The private investors because of "their economic risk" are given areas of land associated with the corridor interchanges for commercial development. *The entire project is designed to benefit the private investors at the cost of the tax paying public.*
- This is a toll road and any operating cost not raised by tolls must be covered by the taxpayers (Gap). The documents project tolls to provide from 29% to 64% of the operating cost. The remaining "Gap funding" could amount to tens of millions of dollars annually.
- Some of the corridor selected is in areas designated as wetlands. Our desire as members of this Council is to preserve these pristine areas for future generations.

WHEREAS, Livingston Parish has had no input into the location and planning of the Baton Rouge Loop project even though approximately 40% of the highway is proposed to be located in Livingston Parish as it is stated in the Tier 1 document that no "on site" studies were conducted;

WHEREAS, the route is poorly planned and disrupts families, schools and businesses;

THEREFORE, BE IT ORDAINED that although Livingston Parish needs desperately to improve highway systems, the proposed Baton Rouge Loop project does not address those needs, is very costly, is divisive to our communities and reflects wasteful government spending and the Livingston Parish Council, and as the governing authority of the Parish of Livingston, hereby oppose the Baton Rouge Loop project and ask that Tier 1 approval not be granted.
