WHEREAS, the Louisiana Local Government Environmental Facilities and community Development Authority (the "Issuer") previously entered into

- (i) a Trust Indenture dated as of December 1, 2015 (the "2015 Live Oak Indenture") by and between the Issuer and Regions Bank (the "Prior Trustee"), pursuant to which the Issuer issued its \$3,820,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Refunding Bonds (Livingston Parish, Louisiana Live Oak Sports Complex Project), Series 2015 (the "2015 Live Oak Bonds");
- (ii) a Trust Indenture dated as of June 1, 2014 (the "2014 North Park Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$9,195,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Refunding Bonds (Livingston Parish, Louisiana North Park Project), Series 2014 (the "2014 North Park Bonds");
- (iii) a Trust Indenture dated as of March 1, 2014 (the "Road Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$21,105,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Refunding Bonds (Livingston Parish Road Project), Series 2014 (the "Road Bonds");
- (iv) a Trust Indenture dated as of March 1, 2014 (the "Jail Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$7,775,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Refunding Bonds (Livingston Parish Jail Project), Series 2014 (the "Jail Bonds");
- (v) a Trust Indenture dated as of September 1, 2011 (the "Courthouse Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$17,865,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (Livingston Parish Courthouse Project), Series 2011 (the "Courthouse Bonds");
- (vi) \$2,500,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (Livingston Parish Sewer District No. 2 Project), Series 2009 (the "Sewerage Bonds");
- (vii) a Trust Indenture dated as of September 1, 2009 (the "OMV Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$4,820,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (Livingston Parish Office of Motor Vehicles Project), Series 2009 (the "OMV Bonds");

- (viii) a Trust Indenture dated as of October 1, 2008 (the "2008 North Park Indenture") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$8,635,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (Livingston Parish, Louisiana North Park Project), Series 2008 (the "2008 North Park Bonds"); and
- (ix) a Trust Indenture dated as of September 1, 2008 (the "2008 Live Oak Indenture" and together with the 2015 Live Oak Indenture, the 2014 North Park Indenture, the Road Indenture, the Jail Indenture, the Courthouse Indenture, the Sewerage Indenture, the OMV Indenture and the 2008 North Park Indenture, the "Indentures") by and between the Issuer and the Prior Trustee, pursuant to which the Issuer issued its \$4,455,000 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (Livingston Parish, Louisiana Live Oak Sports Complex Project), Series 2008 (the "2008 Live Oak Bonds" and together with the 2015 Live Oak Bonds, the 2014 North Park Bonds, the Road Bonds, the Jail Bonds, the Courthouse Bonds and the Sewerage Bonds, the OMV Bonds and the 2008 North Park Bonds, the "Bonds"); and

WHEREAS, the Parish of Livingston, State of Louisiana (the "Parish") now desires to terminate the Prior Trustee as trustee with respect to the Bonds and to appoint Whitney Bank (the "Successor Trustee") as the successor trustee with respect to the Bonds; and

WHEREAS, the termination of the Prior Trustee as trustee with respect to the Bonds and subsequent appointment of the Successor Trustee as successor trustee will not disrupt, delay or otherwise adversely affect the payment of the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of Livingston, State of Louisiana, acting as the governing authority of the Parish of Livingston, State of Louisiana, that:

SECTION 1. Pursuant to Section 9.10 of the 2015 Live Oak Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the 2015 Live Oak Bonds and to appoint the Successor Trustee to serve as trustee with respect to the 2015 Live Oak Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the 2015 Live Oak Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 2. Pursuant to Section 9.10 of the 2014 North Park Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the 2014 North Park Bonds and to appoint the Successor Trustee to serve as trustee with respect to the 2014 North Park Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the 2014 North Park Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 3. Pursuant to Section 9.10 of the Road Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the Road Bonds and to appoint the Successor Trustee to serve as trustee with respect to the Road Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the Road Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 4. Pursuant to Section 9.10 of the Jail Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the Jail Bonds and to appoint the

Successor Trustee to serve as trustee with respect to the Jail Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the Jail Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 5. Pursuant to Section 9.10 of the Courthouse Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the Courthouse Bonds and to appoint the Successor Trustee to serve as trustee with respect to the Courthouse Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the Courthouse Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 6. Pursuant to Section 9.10 of the Sewerage Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the Sewerage Bonds and to appoint the Successor Trustee to serve as trustee with respect to the Sewerage Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the Sewerage Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 7. Pursuant to Section 9.10 of the OMV Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the OMV Bonds and to appoint the Successor Trustee to serve as trustee with respect to the OMV Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the OMV Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 8. Pursuant to Section 9.10 of the 2008 North Park Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the 2008 North Park Bonds and to appoint the Successor Trustee to serve as trustee with respect to the 2008 North Park Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the 2008 North Park Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 9. Pursuant to Section 9.10 of the 2008 Live Oak Indenture, the Parish hereby directs the Issuer to promptly remove the Prior Trustee as trustee for the 2008 Live Oak Bonds and to appoint the Successor Trustee to serve as trustee with respect to the 2008 Live Oak Bonds. The Parish further directs the Issuer to obtain (i) receipt of a written instrument from the Successor Trustee accepting such role and (ii) receipt of a completed assignment between the Prior Trustee as assignor and the Successor Trustee as assignee vesting in the Successor Trustee the rights, immunities and powers of the Prior Trustee under the 2008 Live Oak Indenture and an assignment of any rights held by the Prior Trustee under any associated municipal bond insurance policies and/or any associated municipal bond reserve fund policies.

SECTION 10. The Parish hereby directs the Issuer to require the Prior Trustee to promptly transfer all funds associated with the Bonds and to deliver the Bond

Registers associated with the Bonds (or a copy thereof), together with other pertinent books and records relating to the Bonds, to the Successor Trustee as required by the Indentures.

SECTION 11. The Parish hereby authorizes, empowers and directs the Issuer to provide all notices required by the Indentures, including to any provider of a municipal bond insurance policy and/or surety policy associated with the Bonds, of the termination of the Prior Trustee and appointment of the Successor Trustee.

SECTION 12. The Council Chairman and the Council Clerk of the Parish are hereby authorized, empowered and directed to execute such documents, certificates and instruments as they may deem necessary to carry out the actions contemplated by this resolution.

SECTION 13. All prior approvals and certifications relating to the Indentures and the Bonds shall remain in full force and effect, as amended hereby. Any portions of the Indentures or documents associated with the Bonds in conflict herewith are hereby repealed.

SECTION 14. This resolution shall become effective immediately.

The first being, that the Councilmember could take the complaint themselves, and then submit it on the Council clerk to be forwarded to the Parish President's office. From that point, it is then distributed to the Permit office and the complaint procedure commences. The second choice for the complaint would be to advise the constituent to call the Parish President's office themselves to begin the process. Once the complaint is received by the Permit office, the property owner of the address is verified, an inspection of the property is initiated, and the Permit office then sends a certified letter to the verified owner. If Mr. Vincent determines that the property should be condemned, he notifies the Councilmember of that district to

seek advisement of moving forward with condemnation procedures. An attorney is then employed to make certain determination of the property owner. A letter of condemnation would then be sent to the property owner to appear at a hearing. At the hearing, if the property owner appeared, they would be allowed to make arrangements to clean the property. After their review at the hearing, the Council would then resolve to determine if the property should be demolished. Mr. Vincent gave a history of the slow, long process that condemnations take. He then took questions from the Council and advised that he would meet with any member concerning these issues.

Mr. Vincent then discussed the handout relating to grass, brush, debris ordinance violations. He indicated that it was the same procedure as condemnations. He advised that some property owners complied, some were given extended time to clean up the property, and those who did not respond would then be brought to the Council to determine how to proceed. The chair allowed an open discussion regarding the Parish's need for a mechanism to collect penalty fees for violations.

Mr. Vincent addressed the abandoned vehicle ordinance handout and explained that it was the same process as explained before. He then answered questions from the Council. The chair allowed an open discussion. The chair requested that the Permit office report back to the Council with their findings. The Parish President requested that contact information from the complainant be obtained. The lien procedure was then discussed as well as the long process it takes to complete.
