RESOLUTION

A RESOLUTION GRANTING PRELIMINARY AUTHORITY FOR THE PARISH OF LIVINGSTON, STATE OF LOUISIANA (THE "PARISH"), TO ISSUE, SELL AND

DELIVER IN THE NAME OF THE PARISH REVENUE REFUNDING BONDS IN AN AMOUNT NOT EXCEEDING FOUR MILLION FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$4,450,000), IN ONE OR MORE SERIES, FOR THE PURPOSES OF REFUNDING THE REFUNDED MATURITIES (AS DEFINED HEREIN); SEEKING STATE BOND COMMISSION APPROVAL; PROVIDING FOR THE EMPLOYMENT OF BOND COUNSEL, A MUNICIPAL ADVISOR AND AN UNDERWRITER; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Louisiana Local Government Environmental Facilities and Community Development Authority (the "Authority") has previously issued its \$4,820,000 Revenue Bonds (Livingston Parish Office of Motor Vehicles), Series 2009 (the "Prior Bonds"); and

WHEREAS, the proceeds of the Prior Bonds were loaned by the Authority to Livingston Parish (the "Parish") to (i) fund the construction, equipping and furnishing of a building for the Livingston Parish Office of Motor Vehicles (the "OMV"), and (ii) pay the costs of issuance of the Prior Bonds, including the costs of any bond insurance policy insuring the Prior Bonds; and

WHEREAS, the OMV collects certain service fees pursuant to the provisions of La. R.S. 32:429 and duly adopted ordinances of the governing authority of the Parish (the "Service Fee Revenues"); and

WHEREAS, the Parish desires to secure the Bonds (as defined herein) with the Service Fee Revenues; and

WHEREAS, pursuant to Chapter 13 of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:1421-1430.1, inclusive) the Parish desires to further secure the Bonds with a pledge of all unencumbered revenues accruing to the General Fund (including transfers to the General Fund) of the Parish (the "**General Fund Pledge**" and, together with the Service Fee Revenues, the "**Pledged Revenues**"); and

WHEREAS, the General Fund Pledge will be on a parity basis with the following bonds issued by the Authority on behalf of the Parish: (i) Revenue Bonds (Livingston Parish, Louisiana - Live Oak Sports Complex Project), Series 2008 maturing in years 2016 – 2018, inclusive; (ii) Revenue Bonds (Livingston Parish, Louisiana - North Park Project), Series 2008, maturing in the years 2016 to 2024, inclusive; (iii) Revenue Bonds (Livingston Parish Sewer District No. 2 Project) Series 2009; (iv) unrefunded Revenue Bonds (Livingston Parish Office of Motor Vehicles Project), Series 2009; (v) Revenue Bonds (Livingston Parish Courthouse Project), Series 2011; (vi) Revenue Refunding Bonds (Livingston Parish Jail Project), Series 2014 (viii) Revenue Refunding Bonds (Livingston Parish, Louisiana – North Park Project), Series 2014 and (ix) Revenue Refunding Bonds (Livingston Parish, Louisiana - Live Oak Sports Complex Project), Series 2015 (collectively, the "Outstanding Parity Bonds"); and

WHEREAS, pursuant to Chapters 14 and 14-A of Title 39 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 39:1441-1456, inclusive) the Parish seeks to advance refund certain maturities of the Prior Bonds (the "Refunded Maturities"), thereby realizing savings; and

WHEREAS, the Parish Council of the Parish of Livingston, acting as governing authority thereof (the "Governing Authority") desires to proceed with the issuance of not to exceed \$4,450,000 Revenue Refunding Bonds, in one or more series (the "Bonds") to (i) advance refund the Refunded Maturities, and (ii) pay the costs of issuance associated with the Bonds; and

WHEREAS, the Parish desires to make formal application to the Louisiana State Bond Commission for approval of the Bonds, and further to employ bond counsel and other professionals in connection therewith.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of Livingston, acting as the governing authority thereof, that:

SECTION 1. <u>Preliminary Approval</u>. Application be and the same is hereby formally made to the Louisiana State Bond Commission (the "SBC") for consent and authority for the Parish of Livingston, State of Louisiana (the "Issuer" or "Parish"), to issue, sell and deliver not exceeding Four Million Four Hundred Fifty Thousand Dollars \$4,450,000 of

Revenue Refunding Bonds (the "Bonds"), in one or more series, to bear interest at a rate or rates not exceeding Five Percent (5.00%) per annum, to mature not later than September 1, 2039, all in the manner provided for by Chapters 13, 14 and 14-A of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority supplemental thereto (collectively, the "Act"), for the purposes of (i) advance refunding the Refunded Maturities, and (ii) paying the costs of issuance associated with the Bonds (collectively, the "Refunding"). The Bonds shall be secured by and payable from a pledge and dedication of the Pledged Revenues, on a *pari passu* basis with the Outstanding Parity Bonds, of the Parish.

SECTION 2. <u>State Bond Commission Approval</u>. A certified copy of this resolution shall be forwarded to the Louisiana State Bond Commission ("SBC") by Bond Counsel (defined below), together with a letter requesting the prompt consideration and approval of this application.

SECTION 3. <u>Bond Counsel</u>. This Governing Authority finds and determines that a real necessity exists for the employment of special bond counsel in connection with the issuance of the Bonds. The Boles Law Firm, APC, of Monroe, Louisiana is hereby appointed as bond counsel ("Bond Counsel") to do and perform comprehensive legal and coordinate professional work as bond counsel with respect to the issuance and sale of the Bonds. Said Bond Counsel shall prepare and submit to this governing authority for adoption all of the proceedings incidental to the authorization, issuance, sale and delivery of such Bonds, and shall furnish its opinion covering the legality of the issuance of the Bonds. The fee of Bond Counsel shall be fixed at a sum not exceeding the maximum fee allowed by the Attorney General of the State of Louisiana's fee schedule for comprehensive, legal and coordinate professional work in connection with the issuance of revenue bonds and based on the amount of the Bonds actually issued, sold, delivered and paid for, plus "out-of-pocket" expenses, said fees to be contingent upon the issuance, sale and delivery of said Bonds. A certified copy of this resolution shall be submitted to the Attorney General of the State of Louisiana for his written approval of said employment and of the fees herein designated.

SECTION 4. <u>Appointment of Municipal Advisor</u>. Government Consultants of Louisiana, Inc. of Baton Rouge, Louisiana is hereby appointed and employed as municipal advisor in connection with the Bonds (the "Municipal Advisor"), any compensation to be subsequently approved by the Parish and to be paid from the proceeds of the Bonds, contingent upon issuance of the Bonds.

SECTION 5. <u>Underwriter.</u> It is hereby recognized, found and determined that a real necessity exists for the employment of an underwriter in connection with the issuance of the Bonds. Crews & Associates, Inc. of Little Rock, Arkansas is hereby appointed and employed as underwriter (the "Underwriter") in connection with the Bonds. Any compensation to the Underwriter is to be paid from the proceeds of the Bonds and is contingent upon issuance, sale and delivery of the Bonds; and all costs incurred by the Underwriter in conjunction with the issuance, sale and delivery of the Bonds must be reasonable and approved by this Governing Authority.

SECTION 6. <u>Bond Purchase Agreement.</u> If deemed necessary upon advice of the Municipal Advisor, the Chairman is authorized to enter into, execute and deliver a Bond

Purchase Agreement (the "BPA") with the Underwriter in such form as the Chairman deems appropriate upon advice of Bond Counsel provided however that no BPA shall be executed prior to approval of the issuance of the Bonds by the SBC.

SECTION 7. Other Professionals. Should it be necessary to engage other professionals, the Chairman shall be entitled to engage such professionals provided the contracts employing such professionals shall be promptly submitted to this Governing Authority.

SECTION 8. Professionals to Proceed. Bond Counsel, the Municipal Advisor, and the Underwriter are hereby authorized and directed to proceed with the issuance of the Bonds and Bond Counsel is authorized and directed to prepare necessary documents appertaining thereto and to present them for further action by this Governing Authority.

SECTION 9. State Bond Commission Swap Policy. By virtue of Issuer's application for, acceptance and utilization of the benefits of the Louisiana State Bond Commission's approval(s) resolved and set forth herein, it resolves that it understands and agrees that such approval(s) is expressly conditioned upon, and it further resolves that it understands, agrees and binds itself, its successors and assigns to, full and continuing compliance with the "State Bond Commission Policy on Approval of Proposed Use of Swaps, or other forms of Derivative Products Hedges, Etc.", adopted by the Commission on July 20, 2006, as to the borrowing(s) and other matter(s) subject to the approval(s), including subsequent application and approval under said Policy of the implementation or use of any swap(s) or other product(s) or enhancement(s) covered thereby.

SECTION 10. <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption hereof.
