### L.P. RESOLUTION NO. 16-172

A RESOLUTION TO CREATE THE LIVINGSTON PARISH AIRPORT AND ESTABLISH THE DISTRICT BOUNDARIES, DOMICILE, TERMS IN ACCORDANCE MEMBERSHIP AND WITH THE REOUIREMENTS OF LOUISIANA REVISED STATUTE 2:311 THROUGH LOUISIANA REVISED STATUTE 2:330.

WHEREAS, Louisiana Revised Statute 2:311 authorizes the governing authorities of the parishes of Louisiana to create airport districts; and

WHEREAS, Louisiana Revised Statute 2:313 through Louisiana Revised Statute 2:316, provides the method for giving notice of intent to create the airport district, its publication of notice and the designation of a public hearing to hear all objections interposed to the boundaries of the proposed airport district and to the inclusion of the property proposed to be included in the district; and

WHEREAS, Louisiana Revised Statute 2:315 allows the governing authority of the parish at the time of the public hearing to change the boundaries of the proposed district to exclude therefrom the lands of persons objecting, or by including the lands of persons petitioning to be included therein; and

WHEREAS, the Livingston Parish Council likewise desires to determine the creation of an airport district within the parish of Livingston, adopting the boundaries of the district, thereby defining the domicile, establishing the board and its membership, and also ascertaining the board terms and giving it a numerical designation and name as indicated in Louisiana Revised Statute 2:316;

NOW, THEREFORE, BE IT RESOLVED, by the Livingston Parish Council, governing authority of the Parish of Livingston, the establishment and creation of the Livingston Parish Airport District in accordance with the provisions of law, and having, as mandated, published a Notice of Intent in the Official Parish Journal, conducted and concluded a public hearing on Thursday, May 12, 2016, in the Livingston Parish Council Chambers, 20355 Government Boulevard, Livingston, Louisiana, whereby allowing public comments and disposing of all objections interposed to the boundaries; and

## BE IT FURTHER RESOLVED THAT:

- A. In this manner, it is hereby established that Livingston Parish Council, governing authority of the Parish of Livingston, does consent and authorize the creation of the Livingston Parish Airport District pursuant to Louisiana Revised Statute 2:316.
- B. The legal boundaries of the Livingston Parish Airport Authority District are hereby comprised of all the territory located within the boundaries of Livingston Parish outside of incorporated areas of the Parish.
- C. The domicile of the Livingston Parish Airport Authority District will be the Parish seat; said domicile may be relocated within the geographical boundaries of the district pursuant to Louisiana Revised Statute 2:323.
- D. The Board of Commissioners of the Livingston Parish Airport District shall consist of seven (7) members, or their designee:
  - i. Four (4) members of the Livingston Parish Council, or their designee; and
  - ii. One (1) member of the Livingston Parish delegation from the Louisiana State Senate, or their designee, and
  - iii. One (1) member of the Livingston Parish delegation from the Louisiana State House of Representatives, or their designee, and
  - iv. The Livingston Parish President, or one (1) member being his designee
- E. Appointment and the terms of the first appointed Livingston Parish Airport District Board of Commissioners shall be as follows:
  - i. Two (2) of the first appointed of the Board of Commissioners shall hold office until two (2) years from the date of January first (1<sup>st</sup>) immediately succeeding their appointment, and
  - ii. Two (2) of the first appointed Board of Commissioners shall hold office until three
    (3) years from January first (1<sup>st</sup>) immediately succeeding their appointment.
  - iii. Two (2) of first appointed Board of Commissioners shall hold office for four (4) years from January first (1st) immediately succeeding their appointment.
  - iv. One (1) of the first appointed Board of Commissioners shall hold office for five (5) years from January first (1<sup>st</sup>) immediately succeeding their appointment.
  - v. Thereafter, each member of the Livingston Parish Airport District Board of Commissioners that is appointed shall serve for a term of five (5) years and shall serve without compensation.
- F. The Livingston Parish Airport District shall elect a chairman, vice-chairman, secretary and treasurer among its membership. Additional officers and/or committees will be determined by the Authority. The treasurer shall furnish a special bond for the faithful performance of the duties of their office. The governing authority of the district shall fix the amount of the bond and the airport district shall pay the premium for the treasurer's bond as provided in Louisiana Revised Statute 2:322.
- G. The Livingston Parish Airport District, which is geographically located in the state of Louisiana, shall be a political subdivision of the state within the meaning of Sections 30 et seq. of Article VI of the Constitution of Louisiana and of the provisions of the Louisiana Revised Statutes relating to the levy of taxes, the incurring of debt, and issuing of bonds as stated in Louisiana Revised Statute 2:312.
- H. The Livingston Parish Airport District shall adopt such rules and regulations as may be necessary for its governance, and unless revised by the Authority, shall follow Roberts

Rules of Order. In that regard, a majority of the Authority shall constitute a quorum for the transaction of business. Meetings shall be publicized in accordance with the laws of the state of Louisiana.

I. The Livingston Parish Airport District shall maintain an accounting system and annual budget for the District in accordance with the best recognized practices in governmental accounting. The books and records of the District shall be subject to audit annually in the same manner as is provided for all public subdivisions of the state of Louisiana.
