#### L.P. RESOLUTION

WHEREAS, the Louisiana Department of Transportation will provide for the installation of roadway lighting on I-12 @ Juban Road; and

WHEREAS, prior to installation of said lighting system, the Parish of Livingston must enter into an agreement with the Louisiana Department of Transportation which obligates the Parish to pay 10% of the construction cost, and assume all legal liability for, and all maintenance and energy cost, of said system; and

WHEREAS, in order to proceed with the design of said roadway lighting system, the Department of Transportation and Development requires that the governing authority authorize the Parish President to execute the subject agreement on behalf of the Parish.

BE IT RESOLVED by the Livingston Parish Council, governing authority of the Parish of Livingston, that Parish President is hereby authorized to execute on behalf of the Parish of Livingston, an agreement with the Louisiana Department of Transportation and Development which obligates the Parish to pay 10% of the construction cost, and assume all legal liability for, and all maintenance and operating cost, of the subject lighting system.

BE IT FURTHER RESOLVED that if any portion or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without invalid provisions, items or applications and to this end the provisions of this resolution are hereby declared severable.
