APPROVE A MEMORANDUM OF UNDERSTANDING WITH THE INTENT TO DOCUMENT THE INTENTION OF THE PARTIES LISTED ABOVE AND ENTER INTO AN AGREEMENT TO PROVIDE FOR THE RESPONSIBILITIES AND DUTIES OF EACH PARTY TO ESTABLISH A TEMPORARY EARLY VOTING SITE AND TEMPORARY POLLING PLACE FOR ELECTION DAY AT JUBAN CROSSING FOR THE NOVEMBER 8, 2016 PRESIDENTIAL/CONGRESSIONAL/OPEN PRIMARY ELECTION AND THE DECEMBER 10, 2016 ELECTION.

EARLY VOTING FOR THE NOVEMBER 8, 2016 ELECTION IS TO BE TO BE HELD IN ACCORDANCE WITH LAW FROM 8:30 A.M. UNTIL 6:00 P.M. ON TUESDAY, OCTOBER 25, THROUGH TUESDAY NOVEMBER 1, 2016 EXCLUDING SUNDAY. EARLY VOTING FOR THE DECEMBER 10, 2016 ELECTION IS TO BE HELD IN ACCORDANCE WITH LAW FROM 8:30 A.M. UNTIL 6:00 P.M. ON SATURDAY, NOVEMBER 26, 2016 THROUGH SATURDAY, DECEMBER 3, 2016, EXCLUDING SUNDAY.

THE PARTIES HAVE DETERMINED THAT DUE TO THE STATE OF EMERGENCY IN LOUISIANA, TERMED THE GREAT FLOOD OF 2016, THE NEED TO PROVIDE A TEMPORARY VOTING SITE TO AS MANY VOTERS WHO HAVE BEEN DISPLACED, AN OPPORTUNITY TO VOTE AT A CENTRALIZED LOCATION, OVER A LONGER PERIOD OF TIME, RATHER THAN JUST ON ELECTION DAY.
