The Livingston Parish Council will add by addendum the following item(s) on the agenda for the February 9, 2017 regular meeting of the Council:

- A-1:** Discussion and consideration to adopt resolution to allow two (2) additional board members to expand Gravity Drainage District No. 2 from five (5) members to seven (7) members, request Legislative representation to amend state law accordingly, and publish mandates in the Official Journal – Garry “Frog” Talbert
- A-2:** Adopt resolution to allow the board membership of consolidated Sewer Districts No. One (1) and No. Two (2), now to be known as “Livingston Parish Sewer District”, to expand their current five (5) member board to seven (7) members, request Legislative representation to amend state law accordingly, and publish mandates in the Official Journal – Garry “Frog” Talbert
- A-3:** Adopt resolution to allow Southern Light Fiber, L.L.C. to place fiber optic cable within the public rights-of-way for the following:
- a. North Oaks Medical Center Denham Springs – 31839 LA 16 Denham Springs (Council District 4)
The build 1 mile down 64 and 16.
 - b. North Oaks Med Center Livingston -17199 Spring Ranch Road
This is a 3 mile build down South Satsuma Road (Council District 6)
 - c. Verizon Satsuma (Council District 6)
This is a build in conjunction with the North Oaks Med Center Livingston build along South Satsuma Road
 - d. B*West Livingston to Walker Road ^2 and B*West Livingston to Walker Road^1 (Council District 1)
This is a build down Friendship Road and Buck Carroll Road.
This is part of the network that needs to be built to make it to North Oaks Hospital
 - e. B*Central City to Walker Road ^5 (Council District 3)
This is a build down Amite Church Road that is also needed for North Oaks Hospital.
 - f. Duff Road (Council District 7)
This is a 1200 foot build down Westcoll Road to provide service to a cell tower.
 - g. Hess Road (Council District 2)
This is a 2000 build down Cloverleaf Drive to provide service to a cell tower.
