Mr. Ryan wished to address the Councilmembers to identify that his team's work had been done *gratis*, at no charge for elections for many years. He explained the advantages of having one (1) communicator to coordinate elections for all of the Parish's districts and the costs savings. The chair allowed the Councilmembers to acknowledge and testify to their experiences with Mr. Ryan which concurred with his statements.

The chair addressed agenda item 11, "Parish President's Report":

- a. Approve request from the Livingston Parish Assessor's office to construct a new office building on approximately 2.5 acres on the Parish Council property fronting Frost Road
- b. Approval to enter into a Cooperative Endeavor Agreement with the Livingston Parish Assessor's office
- c. Approve the selection of Alvin Fairburn and Associates as the Engineer/Architect on the construction property

Parish President Layton Ricks informed the Councilmembers that all that was needed at this time was to approve the Assessor's office to move forward with any plans and allow Alvin Fairburn to be the architect of the project. He advised that the Assessor would be paying all of the bills and it would be no cost to the Parish. Once the agreements had been prepared, if the resolution to proceed was voted upon and passed, any and all agreements would be brought before the Council for their approval. This would include: any documentation with mandated signatures, Cooperative Endeavor Agreements, any plans, and hopefully could come to the Council for their approval at the next meeting, if not, it may be the next meeting or after that. He insisted that all of that would come before the Council for their approval. He again stated, that all that was needed at this time was the acknowledgement that the Assessor was authorized to begin and move forward. The chair asked if the Parish President would like to have agenda item 11a voted upon. The Parish President advised that his agenda items, listed as 11 a, b, and c, should have been listed as one (1) item. He explained that Parish Assessor Jeff Taylor was only seeking permission to know that he can advise Alvin Fairburn's office to move forward, to which they have already started on the plans, in addition to, Mr. Chris Moody has also begun to draft the Cooperative Endeavor Agreement language.

Again, he stated that this would have to come before the Council, for their approval. The Assessor did not want to move forward at all, if the Councilmembers were not in agreement of the project and it could move forward. The Parish President explained that the Parish would be inheriting a building that the Assessor was paying for and also maintaining.

Councilman Shane Mack requested to address Mr. Mark Harrell regarding federal grant money received that will help clean waterways and clear drainage in the Tickfaw River, Natalbany River and West Colyell Creek. Mr. Harrell explained that his office had submitted for grant funding for seven (7) waterways. The request included the Tickfaw River, from the state park to the St. Helena Parish line (approved), the Natalbany River, from Louisiana State Highway 22 until where Little Natalbany turns left, all the way up the Little Natalbany past the town of Albany (unfortunately, most of that request was denied), the area of King George was also requested (but denied), several others which included the Colyell, which started at Buddy Ellis and go all the way down to the bay (approved), all together totally over three million dollars (\$3,000,000.00). He discussed working with Congressman Garrett Graves, when the projects would be started, the grant match of ten percent (10%). The bridge on River Road was discussed and it was determined that funding for that project will be covered at one hundred percent (100%). The chair allowed a brief open discussion.
