Thereupon the chair declared that the Motion had carried and was adopted.

The chair addressed agenda addendum item A-1, "Parish President's Report: Accept sole bid for auditing services from LAPORTE for year ending 12/31/2017".

Parish President Layton Ricks addressed the Council members and requested that they support Administration's recommendation for auditing services. He advised of the bid advertisement for these services and also explained that emails were sent to eight (8) different firms promoting the need for bids. He complimented LAPORTE on previous work done in the parish.

Councilman Garry "Frog" Talbert questioned Jennifer Meyers, Finance Director, regarding the new mandates of the Legislative Auditor's "Agreed Upon Procedures". He questioned at length the man hours that would be needed and worked by LAPORTE on the audit to meet these procedures, and shared his concerns that the fee amount submitted for their services would be insufficient, as more man hours would be required. The Parish President advised that LAPORTE was aware of the auditing changes and that any additional dollars for their services would not be approved. Councilman Tracy Girlinghouse addressed Mr. Ricks to confirm that that there would not be any additional charges to LAPORTE's fee proposal. Mr. Ricks concurred. Mr. Talbert again stated his concern with regard to Administration's advertisement of the Request for Proposals. His review of the "Scope of Work" included in the advertisement, did not indicate the newly adopted auditing procedures mandated from the Legislative Auditor's office for an auditor. Mr. Ricks gave his word that they would do the audit for the bid amount and would not charge more. Mr. Talbert asked Ms. Meyers for explanation of how the auditing testing procedures

worked. Ms. Meyers explained from the audience, examples of their known procedures and how they may change or differ from time to time. When asked, Ms. Meyers advised that she was comfortable that LAPORTE would be able to complete the audit for the amount submitted for their services of sixty-one thousand five hundred dollars (\$61,500.00).

A resolution authorizing Layton Ricks, Parish President of the Parish of Livingston, to sign a Multi-Parish Emergency Mutual Aid and Assistance Agreement between the Parishes of Jefferson, Orleans (City of New Orleans), Plaquemines, St. Bernard, St. Charles, St. John the Baptist, St. Tammany, Calcasieu, Cameron, Vermilion, St. Martin, Iberia, St. Mary, Ascension, St. James, Lafourche, Terrebonne, Assumption, Livingston, and Tangipahoa for Emergency Mutual Aid and Assistance. (Parishwide)

WHEREAS; coastal Louisiana is geographically vulnerable to a variety of natural disasters; and

WHEREAS; LSA-R.S. 29:726, 29:730.1 & 730.2, recognizes this vulnerability and provides that its intended purposes are to:

- (1) Reduce vulnerability of people and property of the Region to damage, injury, and loss of life and property;
- (2) Prepare for prompt and efficient rescue, care and treatment to threatened or affected persons;
- (3) Provide for the rapid and orderly rehabilitation of persons and restoration of property; and
- (4) Provide for cooperation and coordination of activities relating to emergency and disaster mitigation, preparedness, response and recovery; and

WHEREAS; in addition to the State, the Federal Emergency Management Agency (FEMA) has recognized the importance of the concept of coordination between local governments; and

WHEREAS; Louisiana Revised Statutes, LSA-R.S. 29:730 authorizes and encourages Parish's to enter into Regional Agreements for Mutual Aid and Unified Operation during times of disasters; and

WHEREAS; the entities which have chosen to become signatories to this agreement wish to provide emergency mutual aid and assistance amongst one another at the appropriate times; and

WHEREAS; these agencies agree to enter into emergency mutual aid and assistance, with the attached agreement embodying the understandings, commitments, terms and conditions for said aid and assistance.

NOW, THEREFORE, BE IT RESOLVED, by the Livingston Parish Council, Louisiana, acting as the governing authority of said Parish:

SECTION 1. That the duly elected President of the Parish of Livingston is authorized to sign a Multi-Parish Emergency Mutual Aid and Assistance Agreement between the Parishes of Jefferson, Orleans (City of New Orleans), Plaquemines, St. Bernard, St. Charles, St. John the Baptist, St. Tammany, Calcasieu, Cameron, Vermilion, St. Martin, Iberia, St. Mary, Ascension, St. James, Lafourche, Terrebonne, Assumption, Livingston, and Tangipahoa for emergency mutual aid and assistance.

SECTION 2. That this agreement shall be effective upon the Parish President signing the Emergency Mutual Aid and Assistance Agreement.
