The Livingston Parish Council met in regular session duly called, advertised, and convened at its regular meeting place, the Parish Council Chambers, Governmental Building, 20355 Government Boulevard, Livingston, Louisiana, on Thursday, April 12, 2018, at the hour of six (6:00) o'clock p.m. with the following Livingston Parish Council members present:

The chair asked the public to please mute or turn off their cell phones.				

The chair announced that Public Input would be accepted from any member of the audience wishing to address an agenda item.

The chair addressed agenda item 7, "Introduction of ordinance providing for the dissolution of Recreation District No. 5 of the parish of Livingston, State of Louisiana and (within the boundaries of the former district as set forth herein), the creation of (i) Recreation District No. 5 south of the parish of Livingston, state of Louisiana and (ii) Recreation District No. 7 of the parish of Livingston, state of Louisiana, and to provide for other matters in connection therewith" and called upon Mr. Jim Ryan, of Government Consultants, Inc. and Parish Financial Advisor, to explain the proposed ordinance.

Mr. Ryan briefly advised of the need for the ordinance to divide the current recreation district, Recreation District No. 5, into two (2) recreation districts to be named Recreation District No. 5 South and Recreation District No. 7. He explained that the current district's debts were paid, the bonded indebtedness has been paid, and the ordinance included language for the disposition of the district's real property to be awarded to the district that it is in the boundaries of. Any real property located within the boundaries of Recreation District No. 5 South would go to that respective recreation district, while any real property located within the boundaries of Recreation District No. 7 would be obtained by that district.

Having no comment from the audience or the membership of the Council, the chair requested a motion for the introduction of the ordinance and directed the Council clerk to read the ordinance by title.

Mr. Ryan also wished to state that upon the recommendation of the Parish's Legal Counsel, Mr. Christopher Moody, the proposed board members' terms of expiration were staggered. If any of the Councilmembers did not like the order of the board members' expiration dates and wished to have them amended, it would be a minor change to the ordinance, and he requested them to please let him know what their wishes were.
