The chair asked the public to please mute or turn off their cell phones.

The chair addressed agenda item 8, "Adopt a Resolution authorizing Livingston Parish Sewer District to proceed with the issuance and delivery of its not to exceed \$11,900,000 of Revenue Bonds, in one or more series; and otherwise providing with respect thereto" and called upon Councilman Garry "Frog" Talbert. Councilman Talbert advised that he had attended a meeting earlier in the week to become more informed on this topic. He briefly explained the District's intent and called upon Eddie Aydell of Alvin Fairburn and Associates. Mr. Aydell, representative for the Livingston Parish Sewer District, explained that the project would allow a new regional sewer facility south of I-12 in the Juban area. He advised of the area's growth and the great need for public sewer, and that without it, could hinder development. He explained of developers in the area who applied for a sewer discharge permit and were denied. He continued to discuss how the businesses and residences in this area that are currently existing were evaluated, and projections of what the needs will be in the immediate future. He indicated that the new facility will financially succeed and basically fund itself without any additional revenue from the sewer district's existing customers. Mr. Aydell answered questions from the Council and advised of the new sewer treatment's construction plans that will consist of three (3) project stages: sewer treatment proper, and the collection system would be split up into two (2) additional projects. He briefly explained the construction plans of each of the projects. Mr. Talbert elaborated in great length and detail the sewer plant plans along with the financial effects and concerns. Mr. Aydell expounded on Mr. Talbert's statements.

## PARISH COUNCIL OF THE PARISH OF LIVINGSTON, STATE OF LOUISIANA

#### L.P. RESOLUTION NO. 18-127

A Resolution authorizing Livingston Parish Sewer District to proceed with the issuance and delivery of its not to exceed \$11,900,000 of Revenue Bonds, in one or more series; and otherwise providing with respect thereto.

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, it is now the desire of the Parish Council of the Parish of Livingston, State of Louisiana, as the governing authority (the "Governing Authority") of the Parish of Livingston, State of Louisiana (the "Parish") to approve the issuance and delivery of not to exceed \$11,900,000 Revenue Bonds, in one or more series (the "Bonds"), by Livingston Parish Sewer District (the "District"), the proceeds of which will be used by the District for the purposes of (i) acquiring, constructing, extending and improving the sewerage system located within the District (the "Project"); (ii) funding capitalized interest on the Bonds, if necessary; (iii) funding a debt service reserve fund, if necessary; and (iv) paying the costs of issuing the Bonds.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council, as the governing authority of the Parish of Livingston, State of Louisiana, that

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, as amended, and La. R.S. 33:1415, and in accordance with the request of the Board of Commissioners of the District, the Parish Council approves the issuance and delivery of not to exceed \$11,900,000 Revenue Bonds of the District. The Bonds shall bear interest at a fixed rate or rates not exceeding 5.00% per annum, shall mature no later than thirty (30) years from the date of their issuance, and shall be issued under the authority of Section 1430 of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other

constitutional and statutory authority, or such other authority as may be determined by resolution at the time of the issuance of the Bonds.

SECTION 2. The Parish President and Parish Council are hereby authorized and directed to do any and all things necessary and incidental to carry out the provisions of this Resolution and to assist the District in carrying out its functions in connection with the financing.

SECTION 3. This Resolution shall become effective immediately.

Her husband, Billy, concurred. That Mark Harrell, Director of Livingston Parish Office of Homeland Security and Emergency Preparedness is hereby designated Authorized Representative for the Livingston Parish Council to affect the preparation of the pre-application and application to the Statewide Flood Control Program for funding assistance of a flood control project.
- Section 4. That said Authorized Representative's responsibilities shall pertain to technical matters only and shall not include any official act on behalf of the (sponsoring authority),

Having no other comment from the public, the chair closed the Public Hearing.

The chair asked for input from the Councilmembers. Councilman Garry "Frog" Talbert gave a very lengthy dialogue about the public's opinion of the proposed Mosquito Abatement District, his views on the matter, the proposed board's membership and the representation of his constituents. Councilman Jeff Averett advised that he felt that his district's constituency was against a mosquito abatement program but supported this ordinance for Council districts 2 and 3. He encouraged the Council members to support the proposal. Councilman Shane Mack advised that his opinion had not changed on the issue of mosquito abatement. He wished to make sure that everyone realized what was being proposed only affected Council districts 2 and 3. He indicated that he had spoken with Councilmen Talbert and Keen and supported the wishes of their constituency. Councilman Tracy Girlinghouse explained his position on the issue and did not wish to stand in the way of Council districts 2 and 3 having their own program. Councilman John Wascom gave an impassioned statement against government-controlled mosquito abatement programs. He spoke of constituents paying for mosquito control on their own individual properties and then called for the question. Councilman R.C. "Bubba" Harris wished to make a short statement. Councilman Wascom withdrew his call for the question to allow Councilman Harris the opportunity to speak. Councilman Harris discussed the difference of price when hiring commercial companies to treat for individual mosquito control, as opposed to the possible fees associated with government mosquito abatement programs.
