The vice-chair expounded that the committee had made it easier to develop a trailer park without eliminating a lot of regulations. The amendments include the removal of mandated concrete or asphalt used for runners, and limestone would now be allowed, while keeping the density the same. The protective apron made of concrete or asphalt around the driveway was still in place. The committee addressed the turnarounds and the t-turns to make them more practical because ultimately a school bus does not need to go in there, and they were shrunk. But mainly, the changes dealt with concrete and limestone.

Councilman Delatte stated that the wording that he was looking at stated a minimum of one (1) streetlight for every three (3) lots and requested clarification.

The vice-chair stated that the streetlights would be required for every three (3) lots instead of everyone (1) to two (2) lots. He furthered explained the intent of the amendments.

He reminded everyone of what would be on the ballot and encouraged everyone to vote.

Councilman John Wascom requested to comment and stated that this had been the most efficient Parish Council meeting that he had ever seen in the past five (5) years and wished to make the motion to adjourn to which the other Councilmembers and audience jovially applauded and chortled.
