L.P. RESOLUTION NO. 21-169

A RESOLUTION TO AMEND THE LIVINGSTON PARISH REGULATIONS BOOKLET; AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, on April 8, 2021, the Livingston Parish Council adopted L.P. Ordinance No. 21-04, amending Chapter 58, "Road and Drainage", Article IV, "Utilities and Installation in Rights-of-Ways" Section 58-419, "Notification" of the Livingston Parish Code of Ordinances; and

WHEREAS, this amendment establishes the procedure for placement of public and private utilities within Parish right-of way or proposed Parish right-of-way as well as, the notification process for same; and

WHEREAS, All utility companies, communication companies, and their subcontractors shall be required to notify the Livingston Parish Office of Homeland Security and Emergency Preparedness (See Section 18-27, Safety Regulations), in writing, a minimum of three (3) Parish business days prior to entering any Parish right-of-way for the purpose of installing and/or repairing any utility or other ground disturbing/breaking activities. Written notification shall include, all information required for an Emergency Operations Plan (EOP) outlined in the Livingston Parish Regulations Booklet, "Utilities and Other Ground Disturbing/Breaking Activities", adopted into Ordinance in Section 18-27. – Safety regulations.; and

WHEREAS, In the event of any emergency, it shall be the responsibility of the utility company to notify the Office of Homeland Security and Emergency Preparedness as outlined in the Livingston Parish Regulations Booklet, "Utilities and Other Ground Disturbing/Breaking Activities, Section 2: Emergency Work." Notification of emergency work shall include all information listed below:

- (1) Company name;
- (2) Subcontractor(s) (if applicable);
- (3) Parish road name;
- (4) Location of work;
- (5) Date/time emergency began;
- (6) Description of emergency;
- (7) Justification for emergency work;
- (8) Description of work done.

WHEREAS, on May 13, 2021, the Livingston Parish Council adopted L.P. Ordinance No. 21-12, an ordinance to amend Chapter 18, "Disaster Emergencies", Article II, "Communications", Section 18-27, "Safety Regulations", of the Code of Ordinances in and for the Parish of Livingston; and

WHEREAS, the Livingston Parish Council adopted L.P.O. 13-11 on April 25, 2013, creating Chapter 14.3, "Safety Regulations", Article I, "In General", Section 14.3-1, entitled "Safety Regulations" of the Code of Ordinances of Livingston Parish, therefore adopting the Livingston Parish Regulations Booklet; and

WHEREAS, on June 13, 2019 the Livingston Parish Code of Ordinances was recodified revising Chapter 14.3, "Safety Regulations", Article I, "In General", Section 14.3-1, "Safety Regulations", to be hereby known as Chapter 18, "Disaster Emergencies", Article II, "Communications", Section 18-27, "Safety Regulations"; and

WHEREAS, the changes proposed in L.P. Ordinance 19-08 to add provisions in respect to digital file distribution to the Livingston Parish Regulations Booklet, Commercial Building/Hazardous Materials Operations; Section 2 "Requirements", are still in effect in the Livingston Parish Regulations Booklet but serve no purpose in the Livingston Parish Code of Ordinances; and

WHEREAS, the Livingston Parish Council now wishes to amend Section 14.3-1. "Safety Regulations" to reflect the date of the recently revised Livingston Parish Regulations Booklet and to strike-out the amendments made in L.P.O. 19-08 to our code of ordinances with the

understanding that the changes were made and are still effective in the Livingston Parish Regulations Booklet; and

WHEREAS, the Livingston Parish Regulations Booklet, dated September 12, 2013 Edition or any future revisions of said booklet as approved by the Council by resolution, a copy of which is available in the office of the Council Clerk, is hereby adopted as the revised safety regulations of the parish for regulating hazardous material, explosives, underground pipelines, new gas or liquid pipeline construction and placement and the providing for the issuance of permits and fees therefor, and each and all of the regulations, provisions, conditions and terms of the Livingston Parish Regulations Booklet, are hereby referred to, adopted and made a part hereof as if fully set out in this section; and

WHEREAS, on May 27, 2021, the Livingston Parish Council desired to update the Livingston Parish Regulations Booklet by resolution with the following additions:

Operations and Activities

Utility and Other Ground Disturbing/Breaking Activities

These provisions, set forth to protect all current underground utilities within the borders of Livingston Parish, apply to all activities that will or may potentially disturb or break ground. See definition of EXCAVATION or EXCAVATE on page 2 of this booklet. This does not replace the required notification to Louisiana One Call and/or other notification procedures outlined in the Louisiana Underground Utilities and Facilities Damage Prevention Law (LA R.S., Title 40, Part VIII. Underground Utilities and Facilities).

Section 1: Permit/Emergency Operations Plan

- (a) Permit/Emergency Operations Plan Required: No person, firm, partnership or corporation, public or private, shall conduct any excavation, ground disturbing or ground breaking activities of any kind, on, over, across or through any Parish owned road, right of way, canal, drainage ditch, levee or any bayou under the jurisdiction of the Parish Council in the Parish of Livingston, Louisiana (hereinafter referred to as "Parish") without having previously submitted an Emergency Operations Plan (EOP) and obtained a permit from the Parish in the manner hereinafter provided.
- (b) General Conditions under which permit is granted: Applications for permits shall be made in writing to the Livingston Parish Office of Homeland Security and Emergency Preparedness a minimum of three (3) business days prior to the start of the project/work. Such application may be in the form of a letter and shall contain a clear description of the utilities/project/work and its purpose, plans, specifications, location, map of location, and name and address of its owner and of the representative designated by such owner, who may be contacted by the Parish on all future matters, related to the construction, installation, maintenance, and repair of the utilities. In additions, such application shall be accompanied by the following: a business check, certified or cashier's check in the amounts stated in this Section and a letter of compliance with this booklet.
- (c) Fees: All Emergency Operations Plan (EOPs) that are submitted to the Livingston Parish Office of Homeland Security and Emergency Preparedness for review, record and issuance of a permit will be accessed a fee of no more than one hundred dollars, depending on the degree of review needed, each time a plan is submitted.
- (d) The Livingston Parish Office of Homeland Security and Emergency Preparedness shall notify the potentially affected current utility owners of all EOP/Permit submissions for review prior to the issuance of the permit.
- (e) Permit Issuance or Denial: After receipt of an application which meets the requirements, the applicant shall receive a permit or be advised in writing as to why a permit cannot be issued, prior to the work beginning.

Section 2: Emergency Work

Emergency Work: Valid emergency work does not fall under the three business days requirements. Any utilities requiring emergency work or other emergency ground disturbing/breaking work, to provide for the health and safety of Livingston Parish and its residents, must be reported to the Livingston Parish Office of Homeland Security and Emergency Preparedness via its 24/7 On-Call number, 225-686-0721, immediately once the necessity of the emergency work is determined. The information that must be provided in this notification includes, but is not limited to, location, cause and justification of emergency work needed, estimated length of utility interruption, affected areas of utility interruption, potential road closures and duration, other potential hazards, emergency work contact information, etc. If a hazard materials release is involved in the emergency incident (i.e., gas leak, oil on the ground, etc.), the LEPC, through 911 Communications, and the HazMat Hotline, at 877-925-6595, must be notified immediately upon its discovery.

Administration and Enforcement Section 2: Violations

- (j) Utility Companies and Other Ground Disturbing/Breaking Activities: Monitoring and Enforcement
 - (1) The Livingston Parish Office of Homeland Security and Emergency Preparedness, the Livingston Parish Department of Public Works, the Livingston Parish Gravity Drainage Districts, local law

enforcement and fire departments shall have the right to reasonably monitor owner or operators to ensure their compliance with the requirements set forth in this booklet.

- (2) Failure of any owner or operator to comply with these requirements shall be subject to the following:
 - (a) For the first violation, a civil penalty of not more than two hundred fifty dollars.
 - (b) For a second violation of a similar nature within a two-year period from the previous violation, a civil penalty of not more than five hundred dollars.
 - (c) For a third violation of a similar nature within a two-year period from a previous violation, a civil penalty of not more than one thousand dollars.
 - (d) (4) For a fourth and each subsequent violation of a similar nature within a two-year period from the previous violation, a civil penalty of not less than two thousand dollars nor more that twenty-five thousand dollars.
 - (e) Any person, firm, partnership or corporation, public or private, conducting any excavation, ground disturbing or groundbreaking activities who is issued a citation for a violation shall immediately stop all activity until the requirements of this Part are met. Failure to do so shall subject the violator to an additional citation and civil penalty of not more than twenty-five thousand dollars for each such subsequent citation issued.
- (3) Damage to other entity utilities, property, any Parish owned road, right of way, canal, drainage ditch, levee, or any bayou under the jurisdiction of the Parish Council, due to the failure to comply with provisions set forth on this booklet and/or utility markings, plans, etc. provided, shall result in the cost to repair being assumed by the responsible party/firm/partnership or corporation.

NOW THEREFORE, BE IT RESOLVED by the Livingston Parish Council, as the governing authority of the Parish, that the above mentioned additions be added to the Livingston Parish Regulations Booklet, said booklet cover being dated 8 April 2021.

The chair inquired if there was anyone in attendance from the Livingston Parish Planning Department who could address this agenda item. Having no one present, the chair questioned if there was a representative from Quality Engineering representing Loretta Townhomes.

Public input: George McCallum, representing Quality Engineering and Loretta Townhomes

Mr. McCallum conveyed that at the last meeting, Mr. Sam Digirolamo, Parish Planning Director, had addressed the Council members and indicated that this development had the recommendation of the Livingston Parish Planning Commission and met all of the ordinances.

The chair clarified that this item had been deferred from the previous Council meeting at the request of Councilman Shane Mack. Councilman Mack explained that he requested it to be deferred because of the proposed adoption of an ordinance to improve drainage that has since been deferred. He stated that there was no reason to defer this agenda item any longer. He continued and explained that he wished to state for the record that the Planning Department approved this item contingent upon the relocation of the treatment plant.

The chair questioned Mr. McCallum if this issue had been addressed. Mr. McCallum responded in the affirmative that it had been addressed by the engineer.

Councilman R.C. "Bubba" Harris wished to comment that the main concern that he had found from the residents of Montrose, who are the ones that are being affected, was the drainage. Upon speaking with Wesley Kinnebrew, manager of Gravity Drainage District No. 1, a plan has been

put in place to help drain this area of development. This will be achieved by part of the drainage going towards Walker South, and where the townhomes are going be located, will be going around to another drainage canal that will cross Louisiana Highway 16 and lead to Gray's Creek. He opined that by doing these things, it should help with their drainage concerns on Montrose.
