Minutes of the Livingston Parish Council Livingston, Louisiana June 23, 2022

The Livingston Parish Council met in a regular session duly called, advertised, and convened at its regular meeting place, at the Governmental Building in the Parish Council Chambers, 20355 Government Boulevard, Livingston, Louisiana, on Thursday, June 23, 2022, at the hour of six o'clock (6:00) p.m. with the following Livingston Parish Council members present:

The chair called the meeting to order.

The chair asked the public to please mute or turn off their cell phones.

The chair announced that Public Input would be accepted from any member of the audience wishing to address an agenda item and explained the procedure to be called upon.

The chair wished to remind everyone that the Council was getting closer to the implementation of a sign in sheet for Public Input that will be posted, allowing four (4) minutes if you actually sign in. You may call and be put on the list if you think that you may not make it in time to be added. He further explained that if you raise your hand during the meeting, you will be allowed two (2) minutes, so that everyone may have time to speak.

The chair addressed agenda item number 7, "Presentations: Recognition of Dads of Denham – Randy Delatte and John Wascom", and called upon Councilman Randy Delatte.

Councilman Delatte stated that this presentation was for Dads of Denham. He advised that as elected public officials there are times when we are recognized for our service, which is very much appreciated by this Council. He continued to state that he thought that far too often we get wrapped up in everyday operations as elected officials and we forget how important it is to recognize the unelected public servants out there in the trenches, those out there that have the heart of a true servant by nature. He further stated with that being said, it was brought to this Council's attention that we have men out there in the trenches serving, and serving very effectively. These men have held over forty (40) benefits, raising over a hundred thousand dollars (\$100,00.00). They have given away over thirty thousand (30,000) meals and have given away approximately nine hundred (900) toys to children with the value of roughly six thousand dollars (\$6,000.00). They call themselves the Dads of Denham and they have helped people all over this Parish. One of their latest benefits was conducted in Maurepas, where they worked with one (1) of the Leadership Livingston groups to help raise money for the Maurepas school.

Councilman Delatte professed that they were proud to recognize Mr. Ricky Foster and Mr. Dan Bourgeois with Dads of Denham for continuously giving back to all of our communities.

Councilman Delatte wished to present two (2) plaques of recognition to Mr. Foster and Mr. Bourgeois.

Both gentlemen were unable to attend the Council meeting that evening. The chair stated that even though they were not present, they deserved applause for their serving endeavors.

The chair paused to address the next agenda item and wished to clarify if a member of the audience wished to be recognized to speak on agenda item number 6, "Public Input". The chair asked the audience member who wished to speak, if it was something specific listed as an agenda item or did he wish to comment on agenda item number 6, "Public Input". The audience member said he

did not wish to speak under an agenda item but wished to speak under the Public Input agenda item. The chairman invited him to come to the lectern and speak in regard to the agenda item listed as "Public Input."

The gentleman introduced himself as Mr. George Sullivan with Brashier Hathaway Home Services Southern Properties, LLC. He advised that he did have an item on the agenda and thanked the chairman, Councilman Shane Mack and the Parish President for helping to get it on the agenda. He stated that he was not here for that, but for the people that he represents, QDS Seafood, LLC, who have been a part of Livingston Parish for the last twenty (20) years.

The chair interjected and established that Mr. Sullivan was not speaking under the guidelines of agenda item number 6, "Public Input", and explained that when the agenda item that he was speaking about came up on the agenda, he would be allowed to speak at that time to give Public Input.

Councilman Tracy Girlinghouse, Council co-chair, wished to also explain to Mr. Sullivan that the Council was implementing a change in the Council meeting's procedure for the public to speak under Public Input, and asked if he wished to say something about the change in that procedure. He advised the Council members can only talk about a specific item when that item is addressed on the agenda. Councilman Girlinghouse further explained that Mr. Sullivan was speaking about an item that was listed on the agenda.

The chair added to Councilman Girlinghouse's statement that when Mr. Sullivan's item came up on the list of the agenda items, he will be able to be recognized to speak at that time and give Public Input on his listed agenda item.

Mr. Sullivan acknowledged his placement on his agenda item and he stated that the Council had a full agenda. They instructed that Mr. Sullivan would have to wait until they came to that agenda item, just as everyone else in the audience was waiting to address their agenda item.

Mr. Sullivan stated that the new procedure to be implemented for Public Input would be a great way to resolve his misinterpretation of all of this and thanked the Council.

The chairman addressed agenda item number 8, "Councilmen's comments:", and wished to announce to anyone who was not present at the previous Council meeting, that the Council made a decision to move the agenda item, "Councilmen's comments:" up from its standing placement at the bottom of the agenda, and for it to now be addressed earlier on the agenda. He further explained that many of the Councilmembers make acknowledgements and announcements that are happening in their Council districts at that time. By placing this item at the top of the agenda, this would warrant that if anyone who had dropped off and was not participating by the end of the meeting when "Councilmen's comments" came up at the end of the agenda, it would ensure that the Councilmen's announcements could be heard at the beginning of the meeting.

The chair stated that he would be recognizing each Councilman at that time to see if they had anything that they needed or wished to announce to bring to the attention to everyone.

He then called upon each of the Councilmen one by one, to be recognized for comments.

Mr. Meche advised that the Panel wished to meet on a more routine basis, which he thought would be a good thing, so that they can share information and better the service that Acadian can provide to the citizens of Livingston Parish.

**All mandates of the Parish's ordinance requirements had been successfully fulfilled and received by the Council clerk to grant approval for Acadian's annual membership drive and the renewal of their ambulance permit.

"Everyone up here has had good intentions and good ideas and we have worked very quickly to resolve the issues that the moratorium was put in place to resolve. Since April 28th, we've introduced twelve (12) ordinances to fix this Parish and push it forward. We've adopted eight (8) of those ordinances, we've introduced five (5) this evening to be adopted on July 14th.

We worked diligently and took a look at every opinion, every issue, and took into account the state laws that supersede the work we do here.

We have all worked together to make significant changes in the process, expectation and standards set forth in Livingston Parish.

I hope that the work we've done can be appreciated and acknowledged, even if you do not support lifting the moratorium tonight, at the next meeting or even before the sixty (60) to ninety (90) days is up.

I believe that we made a huge impact on the future of Livingston Parish, we still have a way to go, but we put our best foot forward.

Now that we have made these changes and look forward to continuing making positive changes, I believe that we should lift the moratorium, effective immediately, to not delay the everyday citizens that are also being affected.

Based on the actions tonight with the introduction of the amendments to Chapter 125, it is my opinion, that the things this Council can do legislatively to protect our citizens have been accomplished.

I am confident that they will be approved on July 14th.

Therefore, I would like to discuss and possibly take action on lifting the moratorium."

- The changes to be reflected are the new procedural changes for public hearing at the Planning and Zoning Commission (Section 125-11)
- New changes for proof of ownership of property (Section 125-9)
- New procedural changes to allow Planning and Zoning Commission to approve or deny developments/subdivisions. (Section 125-11 and Section 125-13)

- o If denied or a waiver is needed it will come before the Council.
 - Planning CANNOT approve a waiver, only the legislative body can.
- Traffic Impact Study changes per our Parish Engineer (Section 125-20)
 - o Changes made offer her a broader scope to ask for more information if needed
- The ten thousand square (10,000) foot lot size/lot max was added back in for garden homes, which had been taken out previously
 - o Garden home definition was amended to say that the lots had to be less than ten thousand (ten thousand) square feet (Section 125-1)
- An ordinance was recently adopted about RVs. Word was received from the Livingston Parish Permit Department that RVs cannot be hardwired, the Council will need to strike the word "hardwire" and this deletion does not change the intent of the ordinance. (Section 125-3.1)

Councilmen's input: Maurice "Scooter" Keen Garry Talbert

• Ponds cannot be built within thirty (30') feet of the property line (Section 125-25)

Introduction of Ordinance to amend R-1 Zoning Division to reflect the original intent (was a clerical, copy and paste error) and added a lot width of eighty (80') feet.

Introduction of Ordinance to create R-1.5 a division with the 2.5 density requirement and a lot width of seventy (70') feet.

Introduction of Ordinance to create Chapter 126-Commercial Development. The deputy clerk advised that this used to be in the Subdivision Regulations, Chapter 125, and indicated the Parish's legal team had been advising to remove this for a long time and the deputy clerk advised that she finally pulled it out at this time. They will be going with the same procedural changes.

Introduction of Ordinance to create Chapter 127-Multifamily Development. The deputy clerk advised that again, this had been pulled out of Chapter 125, and made the procedural changes.

And the last being, Introduction of Ordinance to expand on Wetland regulations.
